cannot participate in this Bid process. Attendance was required/mandatory.

FOLLOWING ARE: QUESTIONS, ANSWERS, CLARIFICATION OF INFORMATION AND MODIFICATIONS TO THE BID DOCUMENTS

- In Div 11 5313-1, we found a reference to DIV 25 specification section "Lab Control System" but could not find DIV 25 specification section in the bid documents. Spec Section 230923 Direct Digital Control (DDC), this section makes no reference to the fume hoods or control/interlock of the fume hoods or the fume hood vertical guide doors. We are getting word from the fume hood suppliers that without this specification they do not know what to supply.
- A Division 11 53 13, item 1.1, paragraph B. 5. d "Integration of lab control system components into the fabrication of the fume hoods per requirements in Division 25 Section "Lab Control System" to be deleted from the specs. The specified hood shall have built in controls.
- Addendum 4, Q6.2, instructs us to replace the ceiling in portions of the 1st FL and to re-install the existing cameras, controls, light fixtures, diffusers, etc. The existing light fixtures and diffusers may not be able to be used in new ceiling type. Please advise on how to proceed with pricing.
- A Demolish and dispose of the Kitchen area ceiling and hangers in the following rooms, keeping the toilet room ceilings:


Warewashing sanitation, Dilution Basin, Storeroom, Production, Corridor, and Store Rooms (See area outlined in BLUE below), Provide 24"x24" Class "A" commercial kitchen ceiling tiles Armstrong Ultima Health Zone or similar by USG or Certainteed. Provide a coordinating 1" nominal white finished standard 2' x 2' ceiling grid by the same manufacturer as the ceiling tile or by Chicago Metallic. Sprinkler work, diffusers, light fixtures, controls, security cameras, exhaust fans and all other items affixed to the existing ceiling shall be removed,

<u>cleaned</u> and reinstalled in the new ceiling., with allowance of 25% replacement for defective ballasts. The entire first floor affected area

shall be protected and sanitized upon construction completion. Date and time of all trades working in this area shall be coordinated in advance with the school engineer and City College of Chicago. and shall be time compressed to minimize disruption. Include an allowance of \$5000 for replacement lighting fixtures, less the aforementioned allowance for defective lighting ballasts, to provide new LED lighting fixtures and diffusers at Owner's option. Retain the gypsum board ceiling in toilet rooms (see area outlined in RED below); patch and paint if any areas are damaged or partially removed during plumbing installation. Note that plumbing coordination shall locate Tissue Culture sink (2199) over the toilet room shaft below, coordinating with lab work above.

See affected areas in first floor key plan below; red areas are for retained ceilings; blue is for area requiring ceiling replacement.
