## Part I - Questions, Responses and Clarification of Information:

- Q1 Since the new rule for Entry Level Driver Training will be going into effect within the next year or so requires students to obtain 80% "proficiency" in both theory and on the road, would City Colleges want to have specific CDL Proficiency Based training programs on the new truck simulator in area's specific to CDL skill acquisition?
  - A. Yes this would be a great addition to our current training.
- Q2 Is City Colleges interested in a CDL Practice Test that provides a practice "on road" test in the simulator tracking student's performance and proficiency with recorded/data collected on skill and a score?
  - A. Currently this is not done but this will be great.
- Q3 The General Specifications does not ask about or for an individual and class performance scoring system for any programs. Would City Colleges be interested in an integrated feedback system for instructors and students with objective performance scores that show level of skill development and identifies where extra attention is needed?
  - A. Yes
- Q4 There are two training environments/terrain in the specifications that we need some explanation for or elimination from the specification. Please explain the need for or consider eliminating the Swamp and the Mountain Tropical Forest environment in the General Specifications on page 17?
  - A. These are not necessary and both can be removed.

- Q5 Is Schedule D the only form we are required to complete to request MBE/WBE Waiver?
  - A. Section 8 in Appendix 1 outlines submission requirements for waiver consideration
- Q6 Do we have to have MBE/WBE for this bid?
  - A. Please reference Appendix 1 of the RFP Section 6: Counting MBE/WBE Participation toward Contract Goals. The definition of Direct and Indirect Participation credits are defined. Section 8 defines the process for waiver consideration. The Plan does not state the vendor has to be MBE or WBE Company. The Plan references the requirement of some level of MBE/WBE participation on every contract. It also outlines the submission requirements for Schedule D consideration if there are no opportunities for the bidder to utilize MBE and WBE firms either through Direct Participation or Indirect.
