REPORTS

that since 1987, the Board of Trustees has annually renewed agreements with the Public Broadcasting Service [PBS] for the lease of telecourses for open air broadcast and use in learning centers; and

that an Agreement has been negotiated with PBS to license rights to one telecourse for the 1998 Spring Semester [from 1-1-98 to 5-30-98] at the fee listed plus an enrollment fee of \$20.00 per student:

- ▶ NUTRITION PATHWAYS as Biology 107 at a flat fee of \$500.00.

THE CHANCELLOR

RECOMMENDS that the Board of Trustees approves the agreement stating the terms and conditions whereby CCC may be granted a telecourse license for open air broadcast and use in learning centers for \$500.00 plus an enrollment fee of \$20.00 per student; and authorizes the Chairman and Assistant Secretary to execute said agreement on behalf of the Board.





PRODUCER: Dallas County Community College District

DESCRIPTION: NUTRITION PATHWAYS examines nutrition and how it impacts people in their everyday lives through profiles of real-life people. This course is designed for two audiences: the college student enrolled in health programs that have an introduction to nutrition requirement, and/or students who want to learn more about nutrition to apply the knowledge in their lives and the lives of their family.
