(20323) CCC DISTINGUISHED PROFESSORS FOR 1997-98, ALL COLLEGES

The Chancellor presented his recommendations for the 1997-98 Distinguished Professors, noting that this is the highest honor a CCC faculty member can receive. Members of the Academy of Distinguished Professors who were present in the audience were recognized by the Chancellor. Since these awards began in 1986-87, eighty faculty members have been so honored. These prestigious awards are based on outstanding teaching, creative leadership, dedicated service and the enhancement of the intellectual and cultural life of the students served. Temple thanked the committee members for their input in the selection process, and requested that the Board approve agenda item #2E, which listed his recommendations for Distinguished Professors awards:

Dr. Temple announced the following:

- Malcolm X College has won a national award [Sylvio O. Conte Award] for its National Youth Sports Program, which was rated as the best youth program in the nation. The award will be presented in February at a ceremony in Washington DC.
- The upcoming CCC-hosted "Learning Challenge" conference was announced and Trustees were invited to attend. The objective of the conference is to provide faculty development on moving from the traditional classroom to an environment that incorporates technology and innovation.
- A presentation on the District's strategic planning project was introduced by the Chancellor and reviewed by Suarez. The plan is expected to be completed by summer 1998. Following review by the Officers of the District, a final draft will be presented to the Board.

Czadowski asked Suarez to report on the 12-1-97 Committee meeting. An ALSP update was presented which highlighted accomplishments and reviewed the funding formula used by the state. Staff reported on the RFPs received for a new Student Information System, the evaluation process, and requested authorization for the Chancellor to negotiate a contract with the preferred vendor. An upcoming CCC conference was announced.

Pidot reported on the various wiring projects, construction of the new data/communications room, and the Netmail project.
