WHEREAS, due to the recent resignation of the Director of Public Relations, it is necessary to obtain external public relations services for general public relations consultation and media representation; and

WHEREAS, the firm of Rosner and Walsh Public Relations has worked with the CCC Office of Public Relations and has shown the necessary experience and skills to provide the needed comprehensive consulting work for the District; and

WHEREAS, Rosner and Walsh has submitted a proposal to provide these services at a monthly rate of \$6,000.00 plus a maximum of \$500.00 per month to cover out-of-pocket expenses such as postage, copying, printing and messenger service.

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees authorizes the issuance of a purchase order in the total amount of \$39,000.00 to Rosner and Walsh Public Relations, 650 N. Dearborn, Chicago, for the provision of public relations consulting services as outlined above.
