REPORTS

that the Board of Trustees has authorized renewal agreements with Dallas Telecourses for the lease of telecourses for open air broadcast and in use in learning centers since 1984; and

that an Agreement has been negotiated with Dallas to license rights to the following 5 telecourses for the Spring 1998 Semester (January 1, 1998 through May 31, 1998) at the fees listed plus an enrollment fee of \$20 per student:

THE AMERICAN ADVENTURE as History 111 at a flat fee of \$500;

IN OUR OWN IMAGE as Humanities 201 for a flat fee of \$500;

IT'S STRICTLY BUSINESS as Business 101 for a flat fee of \$500;

LIVING WITH HEALTH as Health 250 for a flat fee of \$500; and

SOCIOLOGICAL IMAGINATION as Sociology 203 for a flat fee of \$500.

RECOMMENDS

that the Board of Trustees approves the Agreements with Dallas Telecourses stating the terms and conditions whereby City Colleges of Chicago is granted 5 telecourse licenses at a total of \$2,500.00 plus an enrollment of \$20 per student; and authorize the Chairman and Secretary to execute this Agreement on behalf of the Board.

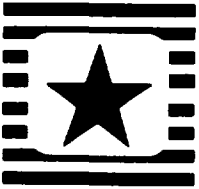

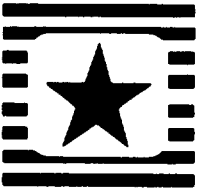
