REPORTS

that it is necessary to purchase dental equipment and supplies for the Dental Hygiene Program at Kennedy King College; and

that the Dental Hygiene Program, an educational partnership with the UIC College of Dentistry, requires various quantities of equipment and supplies such as cleaning tools, powders, steripaks, periodontal models, anatomical rooted teeth, brushing demo models, air polishing units, etc.; and that the required equipment and supplies were grouped in Sections 1 through 11 in order to allow vendors bids by categories; and

that specifications were prepared by Central Office staff, publicly advertised as required by law, with notifications sent to 25 firms; and specifications were distributed to 16 firms; and that the results listed below are the low total bids recommended by staff according to Sections 1 through 11:
