REPORTS

that technical services are needed from Oracle Corporation to assist CCC with the Oracle Government Financial (OGF)-Financial Management System (FMS) financial applications; specifically, OIT and Finance will need Oracle support to implement the OGF/Graphical User Interface (GUI) application; and

that Oracle is the software developer of the OGF software and is therefore needed to implement the OGF/GUI application, and to respond to any CCC questions or issues which arise relating to the application; and that Oracle has proposed to provide the necessary software updates and maintenance services from January 16, 1998 through January 15, 1999, at a total cost of \$185,220.00; and this proposal has been reviewed and approved by OIT; and

that this purchase is exempt from competitive bidding requirements.

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees authorizes the issuance of a purchase order to Oracle Corporation, Belmont, California, in the total amount of \$185,220.00 to provide software upgrades and maintenance services related to the OGF/GUI project from January 16, 1998 through January 15, 1999.

WAIVER OF COMPETITIVE BIDDING REQUIREMENT

Board Rules state that it is the general policy of the District to use competitive bidding procedures to select professional service consultants. Section 4 of the Board Rules lists situations in which a waiver of competitive procedure is possible. In order to retain a consultant without competitive procedures, this waiver form must be completed and approved by the College President, the appropriate Vice Chancellor, or the Chancellor.

Brief Description:

Oracle technical services are needed to assist with the OGF/FMS financial applications.

Type of Service:

OIT and Finance will need Oracle support to implement the OGF/GUI application. Also, Oracle developed the software and is required to respond to CCC's questions relating to the application.

Reason that Competitive Bidding is not appropriate:

Oracle is the sole source of the OGF software. Due to license restrictions, CCC cannot obtain system updates and access from any other vendor. Only Oracle can assist CCC with the Oracle database system.

Basis for selecting the recommended individual or firm:

CCC needs the services and knowledge of the Oracle technical and consulting staff to provide support for the Oracle database which will be used for all applications at CCC and the OGF financial application.
