REPORTS

that the Board of Trustees has authorized renewal agreements with Dallas Telecourses for the lease of telecourses for open air broadcast and in use in learning centers since 1984; and

that an Agreement has been negotiated with Dallas to license rights to the following telecourses for the Summer 1998 semester (June 1, 1998 through August 31, 1998) at the fees listed plus an enrollment fee of \$20 per registered student:

Its Strictly Business as Business 111 at a flat fee of \$500;
A Writer's Exchange as English 101 at a flat fee of \$500;
America in Perspective as History 112 at a flat fee of \$500; and
In Our Own Image as Humanities 201 at a flat fee of \$500.

RECOMMENDS

that the Board of Trustees approves the Agreement with Dallas Telecourses stating the terms and conditions whereby City Colleges of Chicago is granted 4 telecourse licenses at a total of \$2000.00 plus an enrollment of \$20 per student; and authorizes the Chairman and Secretary to execute this Agreement on behalf of the Board.

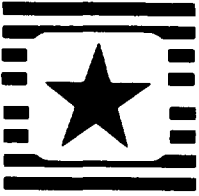
