AMENDMENT TO AGREEMENT
BETWEEN

CITY COLLEGES OF CHICAGO

The Agreement entered into the 6th day of August, 1998 by and between the Board of Trustees of Community College Dist. No. 508, County of Cook and State of Illinois ("Board"), and the City of Chicago, Department of Personnel ("DOP"), is hereby amended as follows:

1. Paragraph 5 shall be amended as follows:
 - 5.a.iv. **Course Enrollment Limit.** It is mutually understood by the parties that in the event of over enrollment of any DOP course, DOP shall have the right to limit CCC employee enrollment to no more than 50% of the total course enrollment.
 - 5.b.ii. **Continuing Education ("CEU") Credit.** City of Chicago employees will automatically earn continuing education units ("CEUs") upon completion of qualified DOP Courses.
2. Paragraph 5.b.iii. is hereby deleted.
