NEW GRANTS

Business and International Education Program (PD# 9871). Wright College has requested \$200,000 from the U.S. Department of Education to promote education and training to businesses that will engage in commerce abroad. Period of performance: September 1, 1999 through August 31, 2001.

Center for District Learning: Minority Faculty Training (PD# 9872). District Office (as part of the Chicago Consortium for Higher Education) has requested \$70,000 from the Illinois Board of Higher Education to establish a training center in technology for minority faculty. Period of performance: September 1, 1998 through July 31, 1999.

Leadership and Core Values Program (PD# 9874). District Office has requested \$15,000 from the Illinois Community College Board to explore, adopt, and implement a set of core values into the campus communities. Period of performance: November 1, 1998 through June 30, 1999.

Head Start/Child Care: Extended Hours (PD# 9879). District Office has requested \$240,952 from the Chicago Department of Human Services to provide extended night time head start/child care to low-income parents at Kennedy-King and Dawson. Period of performance: July 1 through November 30, 1998.

Opening Doors and Changing Lives (PD# 9880). Kennedy-King College has requested \$500,000 from the Illinois Community College Board to provide lowincome unemployed and underemployed persons access to short-term vocationaltechnical training that will lead to immediate and successful entry-level employment. City Colleges of Chicago has requested \$210,741 from the Illinois State Board of Education to provide meals to children attending child care centers at Daley, Kennedy-King, Malcolm X, Olive-Harvey, and Truman Colleges and Dawson Technical Institute. Period of performance: October 1, 1998 through September 30, 1999.

Chicago Public Schools Direct Instruction Project (PD# 9870). Malcolm X College has requested \$500,000 from the Chicago Public Schools to implement a direct instruction program for low-performing students in the Chicago Public Schools. Period of performance: August 24, 1998 through June 30, 1999.
