THE CHANCELLOR

REPORTS

that on June 10, 1998 the Illinois State Board of Education notified the City Colleges of Chicago that a renewal application for FY'99 funding in the amount of \$2,273,000 was approved for the Truants' Alternative and Optional Education Program (TAOEP), to continue providing an extensive delivery of alternative and optional education programs and services to retrieved high school dropouts 16 to 21 years of age through the Alternative Education Consortium which includes the Truman Middle College located at Truman College; and

that of the \$1,297,620 allocated for CCC programs, \$396,405 was budgeted for Truman Middle College; and an integral component for the Truman Middle College model is the clinical counseling achieving dual goals of counseling at-risk students individually and in groups, and training/consulting with faculty and the principal of the school; and

that the Scholarship and Guidance Association has provided this component to the Truman Middle College since its inception in 1986 and will provide for FY99 a 3/4 time clinical social worker who will provide services 4 days per week, faculty and staff training and consultant services in the amount of \$33,500. All services of the Scholarship and Guidance Association will occur at Truman Middle College during the grant period of August 1, 1998 through June 30, 1999.

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees approve the renewal Agreement with the Scholarship and Guidance Association subject to the specific restrictions and limitations set forth by the Illinois State Board of Education for the period of August 1, 1998 through June 30, 1999, and that the Chairman and Assistant Secretary are authorized to execute the Agreement on behalf of the Board.


