REPORTS

that the Board of Trustees has annually renewed Agreements with Dallas Telecourses for the use of telecourses in open air broadcasts since 1984; and

that Agreements have been re-negotiated with Dallas Telecourses to license rights for the following telecourse from September 1, 1998 to December 31, 1998 at the fees listed plus an enrollment fee of \$20 per registered student:

- > American in Perspective as History 112 at a flat fee of \$475;
- > In Our Own Image as Humanities 201 for a flat fee of \$75;
- > Strictly Business as Business 101 for a flat fee of \$475;
- > Living with Health as Health 250 for a flat fee of \$475; and
- > A writer's Exchange as English 101 for a flat fee of \$475.

RECOMMENDS

that the Board of Trustees approves the Agreements with Dallas Telecourses, stating the terms and conditions whereby the City Colleges of Chicago is granted five (5) telecourse licenses totaling \$2,375.00 plus an enrollment fee of \$20 per registered student; and authorizes the Chairman and Assistant Secretary to execute the Agreements on behalf of the Board.
