**THE CHANCELLOR**

that proposals, contracts, and other special funding instruments are under development or have been submitted by staff at this time.

**NEW GRANTS**

**Aid to Less-than-Half-Time Students Project (PD# 9965)** Malcolm X has been awarded \$75,000 and Truman College has been awarded \$63,000 by the Illinois Student Assistance Commission (ISAC) for demonstration projects to aid less-than-half time students. Period of Performance: 1999-2000 school year.

**Midway Airport Project (PD# 9966)** Daley College is requesting \$151,175 in Community Development Block Grant funds from the City of Chicago to train 150 community residents for work on the new Midway Airport. The residents will be trained in Construction Technology and Retail Sales and as Machinists. The project is a cooperative venture with the Midway Airport Terminal Development Program. Period of Performance: January 1, 2000 through December 31, 2000.

**Horizontes Nuevos: Latin-American Students' Success (PD#9967)** Truman College has requested \$1,843,632 from the Department of Education to increase the retention of Truman students, and to increase the academic achievement and the number of Chicago Public School students going to college. Period of Performance: October 1, 1999 through September 30, 2004.

**Special Needs Training Workshops for Adult Educators (PD#9970)** Wright College is requesting \$43,624 from the Illinois Board of Higher Education to develop and implement workshops to train ABE/GED Adult Educators and tutors to assist Adult Learning Skills Program students with special learning needs. Period of Performance: January 1, 2000 through June 30, 2000.

**Workforce Access Scholarships (PD#9971)** Harold Washington College has requested \$117,733 from the National Science Foundation to provide educational opportunities to talented, low-income students through scholarships that promote full-time enrollment in computer science, engineering and mathematics disciplines. Period of Performance: January 1, 2000 through December 31, 2001.

**Single Parents/Displaced Homemakers Programs (PD#9972)** The District Office has been asked by the Illinois State Board of Education to serve as the fiscal agent to assist nine programs in transitioning participants from the FY 99 Single Parent/Displaced Homemaker programs to the FY2000 Perkins plan. The State Board has provided \$90,000 so that each program can receive \$10,000. The programs are Kennedy-King College, Youth Service Project, Erie Neighborhood House, the Greater West Town Community Development Project, Southwest Women Working Together, Sullivan House, the Albany Park Community Center, the Howard Area Community Center, and the Women Employed Institute. Period of Performance: July 1, 1999 - June 30, 2000.

**Gender Equity Projects (PD#9973)** The District Office has been asked by the Illinois State Board of Education to serve as the fiscal agent to assist four projects in transitioning participants from the FY 99 Gender Equity projects to the FY2000 Perkins plan. The State Board has provided \$40,000 so that each project can receive \$10,000. The projects are Chicago Women in Trades, the Greater West Town Community Development Project, Southwest Women Working Together and the YMCA Training Alliance. Period of Performance: July 1, 1999 - June 30, 2000.

**C-Train Support Program (PD#9974)** Malcolm X College has received a subcontract for \$14,739 from the University of Illinois at Chicago to provide support for the C-Train Program. The College will provide a project coordinator and mentor to the program. Period of Performance: September 1, 1998 - August 31, 1999.

#### CONTINUATION GRANTS

**Employment & Beyond Career Center Project (PD#9969)** Wright College has requested \$60,000 from the Illinois Community College Board to provide pre-employment, educational skills training, remediation, career development, employment training, and job placement services to 120 economically disadvantaged JTPA-eligible participants. Period of Performance: July 1, 1999 through June 30, 2000.

**CPS Education to Careers ( PD#9968)** The District has received \$400,000 from the Chicago Public Schools to conduct the Education to Careers Program. Period of Performance: August 1, 1999 through June 30, 2000.

**Early School Leavers Program (PD#9852)** The Illinois State Board of Education has approved a budget increase of \$14,581 to allow a one-time purchase of instructional equipment for upgrading technology within the Program. The original award was for \$287,842; the new total is \$302,423. Period of Performance: July 1, 1998 through June 30, 1999.

**ICCB Grant Awards** City Colleges of Chicago has been awarded a total of \$57,812,034 for the following grants: Base Operating Grant - \$32,084,286; Equalization Grant - \$15,103,132; Special Populations Grant - \$6,477,357; Workforce Preparation - \$1,531,933; Advanced Technology - \$1,426,408; Deferred Maintenance Grant - \$488,918; Retirees Health Insurance Grant - \$700,000. Period of Performance: July 1, 1999 through June 30, 2000.

### **CORRECTION**

**Dropout Retrieval: Empowerment for Academic Matriculation (DREAM) (PD #9962)** The District Office has been awarded \$742,000 by the Chicago Public Schools-Youth Connection Charter School Board to provide academic programs and service for retrieved high school dropouts in the middle colleges. Period of Performance: July 1, 1999 through June 30, 2000. *This was reported on the July 1, 1999 Board Report as Youth Skills Development and Training Program with performance beginning April 1, 1999.*

### **TRANSFER OF GRANT FUNDS**

#### **Phillip Morris, Companies, Inc. Careers in Teaching Grant**

It is necessary to again transfer funds from the above grant to DePaul University's School for New Learning to assist in providing the equivalent of a full-time salary for Anghesom Atsbaha. Mr. Atsbaha has served as a liaison for the Truman College/DePaul University Bridge Program for the past seven years. The School for New Learning will provide Mr. Atsbaha with benefits from their resources. A purchase order will be issued to DePaul University for \$18,000.

### **THE CHANCELLOR**

**RECOMMENDS** that the Board of Trustees approves submission of these proposals to the appropriate funding agencies, and authorizes the execution of all documents by the Chancellor or the Vice Chancellor for Academic Affairs, the Assistant Secretary of the Board and the General Counsel for acceptance of any funding that may be forthcoming; said funds to be subject to the terms and conditions set forth by the grantor, and not to be expended by the Board for any other purposes.
