WHEREAS the Chancellor has reviewed the renewal recommendations of the faculty departments and college administrations to comply with the requirements of the law and the contract for renewing and non-renewing faculty employed for the academic year that commences **August 16, 1999** and ends **May 20, 2000**, and

WHEREAS the following renewals and non-renewals of non tenured faculty have been recommended by the Chancellor,
