**THE CHANCELLOR**

that proposals, contracts, and other special funding instruments are development or have been submitted by staff at this time.

**NEW GRANTS**

**Illinois Virtual Campus (PD# 9901)**. District Office has requested \$30,000 from the Illinois Community College Board to be part of a team of Illinois colleges to provide internet-based distance learning to students throughout Illinois. Period of performance: January 1 through August 31, 1999.

**Postsecondary Tech Prep Student Transition Services (PD# 9902)**. District office has requested \$15,000 from the Illinois State Board of Education to assist existing Tech Prep programs develop and pilot transition services that assist high school students to enter college and receive an Associate of Applied Science (AAS) degree. Period of performance: February 1 through June 30, 1999.

**Cooperative Work Study Program (PD# 9903)**. Olive-Harvey College has requested \$50,000 from the Illinois State Board of Higher Education to develop and implement a cooperative work study program in electronics, computer information systems, and hospitality. Period of performance: July 1, 1999 through June 30, 2000.

**Hispanic Serving Institutions (PD# 9905)**. Truman College has requested \$250,000 from the U.S. Department of Education to increase college enrollment and completion rate of Hispanic students. Period of performance: July 1, 1999 through June 30, 2000.

**Gaining Early Awareness and Readiness for Undergraduate Programs --GEAR UP (PD# 9906)**. Truman College has requested \$250,000 from the U.S. Department of Education to increase the enrollment of disadvantaged students. Period of performance: July 1, 1999 through June 30, 2000.

**Oral Sciences Diversity Initiative (PD# 9907)**. Kennedy-King and Malcolm X Colleges will serve as consultant partners to the University of Illinois at Chicago College of Dentistry in an effort to increase the number of minorities in biomedical research. The partnership has requested \$364,318 (\$41,400 for Malcolm X College and \$41,400 for Kennedy-King College) from the National Institute of General Medical Sciences. Period of performance: July 1, 1999 through June 30, 2001.

**Truman Work-Based Learning Project (PD# 9909)**. Truman College has requested \$18,000 from the Illinois Board of Higher Education to support student cooperative work study programs. Student projects are aimed at reducing student loans, enhancing public-private sector partnerships, and encouraging students to seek employment in Illinois. Period of performance: July 1, 1999 through June 30, 2000.

**Project LAN South (PD# 9910)**. Wright College has requested \$11,028 from the Illinois State Library to set up a Local Area Network (LAN) at Wright College South. Period of performance: March 1 through August 31, 1999.

## CONTINUATION GRANTS

**Learning Resource Center Information Infrastructure Enhancement (PD# 9904)**. Each of the seven City Colleges of Chicago has requested \$6,500 ( $\$6,500 \times 7 = \$45,500$ ) from the Illinois Board of Higher Education to upgrade computer workstations in the libraries. Period of performance: March 1 through August 31, 1999.

**Opportunities Program (PD# 9908)**. District Office has requested \$1,700,000 from the Illinois Community College Board to assure that needy families with children obtain the education and training that will allow them to earn income and move toward self-sufficiency. Period of performance: July 1, 1998 through June 30, 1999.

**Chicago School-to-Work Opportunities System (PD# 9911)**. City Colleges of Chicago, in partnership with the Chicago Public Schools, has requested \$340,000 from the U.S. Department of Education/U.S. Department of Labor to provide curriculum and staff development to participants in School-to-Work schools and occupational clusters. Period of performance: December 1, 1998 through June 30, 1999.

## CONTRACT AMENDMENT

**Foster Parent Training (PD# 9860/C104)**. Harold Washington College has received a contract amendment from the State of Illinois, Department of Children and Family Services for an additional \$630,446 (original \$105,456 + \$630,446 = \$735,902) to prepare qualified adults to become foster parents. Period of performance: July 1, 1998 through June 30, 1999.
