## THE CHANCELLOR

REPORTS

that in Board Report #20484 dated 3-5-1998, the Board authorized the extension of NetIllinois's Internet Service Provider (ISP) services through April 30, 1998, due to delays in the process of implementing an agreement with Genuity/GTE, who was approved as the District's new ISP in Board Report #20275, dated 11-6-1997; however, since that time, GTE has been unable to implement upgraded Internet services as per their agreement and staff has proposed cancellation of the agreement with Genuity/GTE; and

that during the interim period. NetIllinois has continued to provide ISP services and staff recommends continuation of their services through June 1999, at the current rate of \$1750.00 per month, for a total cost of \$24,500.00, which covers the period of May 1998 through June 1999, and

that this purchase is exempt from the District's competitive bidding requirements.

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees approves the extension of NetIllinois' Internet Services Agreement for the period of May 1, 1998 through June 30, 1999, at a total cost of \$24,500.00; and that the Board approves the recission of Board Report #20275 dated 11-6-97 due to the inability to implement required services by Genuity/GTE.
