REPORTS THE CHANCELLOR

that proposals, contracts, and other special funding instruments are under development or have been submitted by staff at this time.

NEW GRANTS

Voyager Expanded Learning Program (PD#9963) Malcolm X Colleges has been awarded \$125,000 by the State Legislature to offer the Voyager Expanded Learning Program to 216 children. The Program is designed to bridge the gaps in educational attainment by providing an innovative K-8 "child-centered" curriculum that improves the children's overall performance. The program addresses the front-end needs of the K-16 initiative. Period of Performance: June 1, 1999 through August 30, 1999.

Strengthening Instruction and Services for Low-Income & Hispanic Students (PD#9961) Truman College has requested \$1,843,632 from the U.S. Department of Education to improve the retention and academic success of Hispanic and low-income students. Period of Performance: October 1, 1999 through September 30, 2004.

KaBoom Project (PD# 9964) Kennedy-King, Olive-Harvey and Truman Colleges have been selected to participate in a playground development matching grant project in which KaBoom along with its corporate partner, CNA Insurance, will donate up to \$20,000 per college in playground equipment, and will install and redesign the playgrounds at the colleges. Each college will raise \$10,000 in support of the project. All services to be performed on August 28, 1999.

CHAMPS Grant (PD# 9956) Malcolm X College has received a grant of \$15,000 from Chicago State University to increase the number of Malcolm X students who transfer to four year universities majoring in science, math, engineering and technology. Curricular and extracurricular experiences will be provided to students. Enrichment opportunities will also be provided to faculty. Period of Performance: May 1, 1999 through August 7, 1999.

Registration Initiative (PD#9952) Harold Washington College is requesting \$10,000 from The College Board's Greenhouse Program to retain essay readers at peak registration times. This will ensure that those who seek higher education will not be deterred by the registration process. Period of Performance: August 1, 1999 through December 31, 1999.

Adopting & Adapting Modular Chemistry for Internet Delivery (PD# 9953) Harold Washington College is requesting \$133,889 from the National Science Foundation in cooperation with Joliet Junior College and William Rainey Harper College. This project will extend the impact of the NSF systematic chemistry initiative by adopting and adapting modular chemistry for internet delivery. Period of Performance: June 1, 2000 through May 30, 2003.

Technology Proficient Teachers - A Pilot Technology Certification Program for Chicago Public Schools (PD#9954) Harold Washington College is requesting \$264,401 from the U.S. Department of Education to develop three courses as part of a technology proficiency certification program and to pilot that program to teachers from the Chicago Public Schools. Period of Performance: September 1, 1999 through August 31, 2002.

Talking to the Animals (PD#9955) The District Office, in partnership with the Lincoln Park Zoo, the Minneapolis Zoo, the Teachers Academy for Mathematic and Science, Roosevelt University, the Chicago Housing Authority, the Charles A. Hayes Family Investment Center, and the Chicago Consortium for Higher Education, has requested \$700,000 per year for three years from the Department of Education. The project will prepare teachers and faculty to use technology by presenting a technology enhanced science course. The teachers and faculty will learn how the course was constructed and then receive assistance in creating similar courses for their students. The Lincoln Park Zoo will serve as the fiscal agent for the project. Period of Performance: September 1, 1999 through August 31, 2002.

Child Care Access Means Parents in School (CAMPUS) (PD#9958) The District Office has requested \$224,051 from the U.S. Department of Education to subsidize the cost of child care services for children of low income students who are working less than 25 hours per week. Period of Performance: June 1, 1999 through September 30, 2003.

CONTINUATION GRANTS

Subsidized Child Care (PD#9859) The Department of Human Services has awarded the District Office an additional \$91,204 for subsidized child care. The original award was \$486,806 and was approved by the Board on July 2, 1998. The new grant amount is \$578,010. Period of Performance: July 1, 1998 through June 30, 1999.

Teen Parent Services (PD#9957) Truman College has been awarded \$153,200 by the Department of Human Services to continue to provide Teen Parent Services. Period of Performance: July 1, 1999 through June 30, 2000.

Subsidized Child Care (PD#9959) The District Office has been awarded \$551,600 by the Department of Human Services for subsidized child care. Period of Performance: July 1, 1999 through June 30, 2000.

Office of Vocational Training and Development (OVTD) (PD#9960) Harold Washington College has been awarded \$444,333 by the Department of Human Services to provide educational services to students with physical and developmental disabilities. Period of Performance: July 1, 1999 through June 30, 2000.

Youth Skills Development and Training Program (PD #9962) The District Office has been awarded \$742,000 by the Chicago Public Schools-Youth Connection Charter School Board to provide academic programs and service for retrieved high school dropouts in the middle colleges. Period of Performance: July 1, 1999 through June 30, 2000.

RECOMMENDS

that the Board of Trustees approves submission of these proposals to the appropriate funding agencies, and authorizes the execution of all documents by the Chancellor or the Vice Chancellor for Academic Affairs, the Assistant Secretary of the Board and the General Counsel for acceptance of any funding that may be forthcoming; said funds to be subject to the terms and conditions set forth by the grantor, and not to be expended by the Board for any other purposes.
