BONAVENTURE TRAVEL PRODUCTIONS LTD. PROGRAM LICENSE AGREEMENT

On this 19th day of May, 1999, **Bonaventure Travel Productions Ltd.**, hereinafter referred to as Licensor
and **WYCC-TV, CHANNEL 20 - 7500 South Pulaski, Chicago, Illinois, USA 60652-1299**
hereinafter referred to as Licensee, have agreed as follows:

1. Licensor hereby licenses under copyright to Licensee for the sole purpose of broadcasting the programs hereinafter designated over the facilities of Station **WYCC-TV in Chicago, IL, USA**

2. The total license fee hereunder is US\$5,000.00, which amount Licensee agrees to pay in 1 instalment of US\$5,000.00.
3. If Licensee fails to perform any of the conditions of this agreement or is at any time in default in the payment hereunder, Licensor shall be wholly relieved from providing films hereunder, and Licensor may at its option declare this agreement to be terminated in which event no further broadcasts shall be made by Licensee.
4. The words, 'film' and 'print', however used in this agreement, shall be construed to apply equally to a program or to a series of programs whether such program or series of programs be produced and made available to Licensee on film or as a Videotape Recording.
5. Licensee acknowledges that Licensor has made no guarantee to Licensee to sell these programs to sponsors and Licensee agrees to pay for these films in accordance with the terms of this agreement whether they are sponsored or unsponsored and whether they are broadcast or not broadcast.
6. Subject to the Broadcast Term provisions set forth above: [a] film series in production shall be broadcast in accordance with the production schedule which shall be furnished to Licensee upon written request, and [b] film series production of which has been completed may be scheduled as Licensee wishes, provided that Licensee notifies Licensor in writing at least two weeks prior to broadcast so that Licensor may arrange for the shipment of prints.
7. If, due to an act of God, federal, state or municipal law, governmental regulations, material shortages, a labour dispute, or for any cause beyond its control, Licensor shall fail to deliver any of the films herein named, such failure will extend to include sufficient time to broadcast such films when they are delivered.
8. This instrument contains all of the terms of the agreement between the parties hereto and there are no others, and it is to be construed and enforced in all respects according to the laws of the Province of Ontario, Canada.
9. Licensor guarantees that all necessary clearances have been acquired for talent, music, and other potential legal claims.
10. Licensor guarantees broadcast quality of tapes.
