NEW GRANTS

Allied Health Grant Agreement (PD# 0172)

Malcolm X College has received a grant from the Illinois Community College Board for \$450,000 to provide services in health related fields including the recruitment of welfare recipients into allied health careers, developing and providing training programs, and providing mentoring, counseling and other services. The project will be implemented during the period from September 1, 2000 through August 31, 2001 except that ICCB will allow grant expenditures, program development, and enrollments dating back to June 1, 1999.

Collaborative HECA Projects (PD# 0173)

The City Colleges of Chicago has agreed to collaborate on a variety of projects which were funded under "Illinois Higher Education Cooperation Act". Some of these projects include Carl Sandburg College's "Statewide Visiting Scholar Program" and Illinois Institute of Technology's "Collaborations: The Mathematics-Science-Technology Initiative" and Northern Illinois University's "Project PRIME Summer Academic Bridge Program". These projects will be implemented during the period from August 22, 2000 until August 31, 2001

HWC Music Academy - A Bridge to College and Career (PD# 0174)

Harold Washington College has requested \$22,470 from the Illinois Board of Higher Education to fund a music academy during the summer of 2001 for 35 students who are juniors in Chicago public high schools. Participating students will then subsequently have the opportunity to earn college credit at Harold Washington College and, upon successful completion, earn a one semester full tuition scholarship to the college. The performance period for the project is from January 1, 2000 until August 31, 2002.

A Proposal to Further Demonstrate a Project Model for Upgrading the Teaching Skills of Chicago Public and Private School Science Teachers (PD# 0175)

Richard Daley College has submitted a proposal for \$60,628 to the Illinois Board of Higher Education under the Eisenhower Professional Development Program to upgrade the skills of predominantly minority teachers in the field

CDHS Head Start Amendment (PD# 0171)

The Chicago Department of Human Services wishes to amend its Child Care Contract with the City Colleges of Chicago (PD# 99109) to include an additional \$527,411 for the purchase of program improvement items for CDHS funded Head Start and Early Head Start delegate agencies. The contract amendment will include \$50,000 in administrative costs for the District Office.

Amana Appliance Gift (PD#0176)


