RESOLUTION

RENEWAL AND NON-RENEWAL OF NON-TENURED FACULTY

WHEREAS the Board of Trustees is required by law, and the collective bargaining agreement with CCCTU Local 1600, to notify non-tenured faculty appointed to academic year appointments commencing any Fall semester of their renewal or non-renewal at least 60 days before the end of the next ensuing Spring semester, and

WHEREAS the Chancellor has reviewed the recommendations of faculty departments and their respective college administrations for renewing or non-renewing faculty employed on calendar year appointments that commenced August 16, 1999, and will end May 20, 2000, and

WHEREAS the following renewals effective for the Fall 2000 semester, and non-renewals effective May 20, 2000 have been recommended by the Chancellor,
