Amend Resolution for Renewal and Non-Renewal of Non-Tenured Faculty adopted February 3, 2000 as Board Report # 21759:


Add **Ms. Michelle Riley**, Nursing, Olive-Harvey College as a renewal for her 3rd appointment, commencing August 16, 2000.
