WHEREAS, the General Counsel has recommended to the Chancellor that Global Settlement of these lawsuits in accordance with the terms of the attached privileged and confidential recommendation is in the best interest of the District;


WHEREAS, the Chancellor adopts the General Counsel's recommendation and recommends that the Board grant the settlement authority requested;

**NOW THEREFORE BE IT RESOLVED,**

that the Board of Trustees of Community College District No. 508, County of Cook and State of Illinois hereby authorizes the General Counsel to negotiate and enter settlement agreements with the estate of Cashen, Busch and IBEW, Local 1220 in full and complete settlement of their lawsuits, inclusive of all claims and costs, including attorneys fees, consistent with the General Counsel's privileged and confidential recommendation. The Board Chairman or designee is hereby authorized to execute the settlement agreements and do all things necessary to implement its terms.
