Capital Project Management System

THE CHANCELLOR

REPORTS

That there is a need to provide a Capital Project Management solution to effectively manage all aspects of Capital Projects related to the 1999 General Obligation Bond and remaining funds from previously issued bonds. The software is called Prolog/ProjectTalk, developed by Meridian Project Systems.

This system will provide the following benefits to the City Colleges of Chicago: Collaborate capital project information with the Public Building Commission of Chicago and the Illinois Capital Development Board (both agencies currently use Prolog); standardize City Colleges of Chicago business process across all capital development projects; increase efficiency by automating repetitive and time-consuming tasks; provides global reporting across all projects. Additionally, the Meridian Systems is currently the only A/E Software solution company that provides the Application Service Provider (ASP) solution for the A/E project management industry.

The initial cost for the software solution is \$11,620 that includes six months of service plus training for eight users. Projected future costs for this solution is approximately \$720 per month for eight users. Funding will be initially derived from City Colleges of Chicago Microfilm Original Fund. Specific funding requirements are as follows:

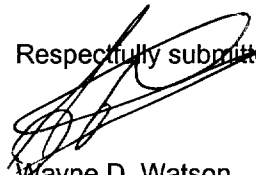
- \$11,620.00 – Third Millennium Technologies for Software and Training for first six months (July through December)
- \$720 per month (January through June) totaling \$4,320

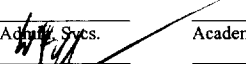
