NEW GRANTS

Legislative Add-On for Malcolm X (PD# 01021)

Malcolm X College has received a legislative add-on through the Illinois Department of Commerce and Community Affairs for \$30,000. The project will support recruitment activities including *Discovery Day*, *Freshman P.R.E.P.*, *Health Career Fair*, and *Senior Day*. The performance period for the project is from July 1, 2000 until June 30, 2002

ASN/Youth Year Round Program (PD# 01022)

The Alternative Schools Network has awarded Olive-Harvey Middle College with a subcontract of \$40,000 from their Workforce Investment Act grant from the Mayor's Office of Workforce Development of the City of Chicago. The project will provide supplemental activities for out of school youth who are enrolled at the Olive-Harvey Middle College. The performance period for the project is from January 1, 2001 until June 30, 2001.

Hands, Minds and a Bit of Grease: A Formula for Success (PD# 01024)

Richard J. Daley College has submitted a proposal for \$273,456 to the Fund for the Improvement of Postsecondary Education of the U.S. Department of Education for a prototype project that would prepare 10th and 11th grade students for technical careers in shortage occupations. The training would be equivalent to that normally provided in the first year of college. The performance period of the three year project is from June 1, 2001 until May 30, 2004.

Redesigning K-16 Articulation: Charting a New Course for Large Urban School Districts (PD# 01025)

The District Office has submitted a proposal for \$861,197 to the Fund for the Improvement of Postsecondary Education of the U.S. Department of Education for a prototype project that would redesign articulation efforts in large urban school districts to include such features as systems thinking and interdisciplinary curriculum development. The performance period of the three year project is from October 1, 2001 until September 30, 2004.

Access, Retention and Completion: A Strategy for African American and Hispanic Students in Higher Education (PD# 01026)

Harold Washington College has submitted a proposal for \$107,460 to the

Fund for the Improvement of Postsecondary Education of the U.S. Department of Education for a project that would increase access, retention and completion rates for African American and Hispanic students enrolled in an Integrative Studies curriculum at Washington College. The performance period of the three year project is from August 15, 2001 until July 16, 2004.

Legislative Add-On for Malcolm X (PD# 01021)

Malcolm X College has received a legislative add-on through the Illinois Department of Commerce and Community Affairs for \$30,000. The project will support recruitment activities including *Discovery Day*, *Freshman P.R.E.P.*, *Health Career Fair*, and *Senior Day*. The performance period for the project is from July 1, 2000 until June 30, 2002

Raising Readers: A Family Affair (PD# 01027)

Kennedy-King College has submitted a proposal for \$35,000 to the Illinois Secretary of State's Office for a project to train parents to participate in effective reading intervention with their children. The performance period for the project is from July 1, 2001 until June 30, 2002.

Arts, Culture and Technology for Language, Literacy, Leadership and Learning (PD# 01028)

Harry S. Truman College has submitted a proposal for \$250,000 to the U.S. Department of Education (Title VII) for a project to provide teachers and teacher educators with alternate theoretical frameworks and innovative approaches to more effectively engage limited English proficient (LEP) students in their learning activities. The performance period for the project is from September 1, 2001 until August 31, 2006.

Telecommunications Training Demonstration Grant for Dislocated Workers (PD# 01029)

Wilbur Wright College has submitted a proposal to the U.S. Department of Labor (Office of Employment and Training) for \$677,239 for a project which would use telecommunications industry-approved training materials to train displaced workers to become installers. Training will include very technical information and lab applications. The performance period for the project is from July 1, 2001 until June 30, 2003.

Mayor's Office of Workforce Development - RFQ (PD# 01030)

Each of the City Colleges of Chicago has responded to a "Request For Qualifications" from the Mayor's Office of Workforce Development (MOWD). The submission of qualifications will allow the colleges to be utilized in contracts funded by the City of Chicago for the provision of training, job preparation, placement, and other workforce related services during the next five years.

CONTINUATION GRANTS

Education To Careers Renewal Agreement (PD# 01031)

The Board of Education of the Chicago Public Schools has renewed its Education To Careers grant agreement with the City Colleges of Chicago for the period from September 1, 2000 through August 31, 2001. The project will provide ETC Coordinators at each of the Colleges and support professional development activities and the development of career guidance materials. The total funding which will be provided to the City Colleges of Chicago for the renewal period is \$400,000.

GEAR-UP (PD# 01032)

Northeastern Illinois University has awarded a continuation subcontract of \$254,411 to Truman College to support efforts to better align standards from high school to college and to improve readiness for college. The project will provide services which increase the proportion of students who leave high school prepared for college. The performance period for the second year of this project is September 1, 2000 through August 31, 2001.

AMENDMENTS

Truants' Alternative and Optional Education Program (TAOEP) (PD#01020)

The Illinois State Board of Education has refunded the TAOEP, at the District Office, for \$2,411,512. This program is a unique partnership between public, private and community-based organizations designed to provide alternative educational programs and services to reclaimed youth, 16-21 years old, who have dropped out of high school. The performance period for this project is from July 1, 2000 through June 30, 2001. From the grant funds, the following agencies will utilize subcontracts from the City Colleges of Chicago which are amended from what was reported in PD#0113 as follows:

Chicago K-16 Partnership: Qualified Mathematics Initiative for Improving Middle School Student Achievement Through Mathematics Endorsements (PD# 01023 - previously PD#0167)

The District Office has received funding of \$70,000 from the Illinois Board of Higher Education through the Eisenhower Professional Development Program for a project that would train 72 middle school teachers to more effectively facilitate student learning in mathematics. The performance period for the project is from January 1, 2001 until December 31, 2001. This project will utilize the consulting services of Dr. Steven Jordan (\$12,000), of the University of Illinois at Chicago, and other professionals from the Chicago Public Schools.

Staff Technical Skills Grant (PD# 01025 - revised from PD#0109)


The Staff Technical Skills Grant, part of the Illinois Community College Board Fiscal Year 2001 Grants to Colleges (PD# 0109) will utilize the consulting services of Dr. Clarisse Croteau-Chonka to advise and train faculty in instructional technology and to assist in the upgrading of instructional technology equipment laboratories and other forms of computer based learning. Dr. Croteau-Chonka will provide these services from February 1, 2001 through June 30, 2001 at a cost of \$5,000 per month.
