WHEREAS, the Illinois Community College Board (ICCB) has approved the RAMP FY 2000 Capital Project Request for the District-wide Workforce Preparation Centers; and that the project budget is \$5,148,000 with the state's allocation being \$3,862,000 and CCC's matching funds being \$1,286,000; and that the Illinois Capital Development Board (CDB) will administer the project for the ICCB;


WHEREAS, Administrative Services staff has conformed with CDB guidelines for selecting the architect, issued a Public Notice for architectural services, rated the 23 respondents and provided a short list of 10 architects to Academic Affairs for review and recommendation of architect;

WHEREAS, that Academic Affairs has reduced the short list to the following choices: BLDD Architects, Inc., Des Plaines; Frega Associates, Ltd., Chicago; Legat Architects, Chicago; and Perkins & Will, Chicago; and that Academic Affairs plans to interview and rank these architects and submit the top three architects to the CDB for selection; and

WHEREAS, the Chancellor recommends that the Board of Trustees authorize the following:
1. Academic Affairs to select and rank three of the four finalist architectural firms; 2. Academic Affairs and Administrative Services to submit the names of the top three ranked architectural firms to the CDB; and 3. Administrative Services to finalize procedures with the CDB for implementing the project, including the transfer of \$1,286,000 in matching funds to the CDB.

NOW THEREFORE, the Board hereby authorizes: 1. Academic Affairs to select and rank three final architectural firms; 2. Academic Affairs and Administrative Services to submit the names of the top three ranked architectural firms to the CDB; and 3. Administrative Services to finalize procedures with the CDB for implementing the project, including the transfer of \$1,286,000 in matching funds to the CDB.


