NEW GRANTS

Preparing Tomorrow's Teachers to Use Technology (PD# 020802)

The District Office has received a grant of \$57,600 to be used for course development for the PT³ program, funded by the Illinois Community College Board. A faculty member from Kennedy-King College, two faculty members from Daley and one faculty member from Olive-Harvey College will serve on the PT³ Communications Curriculum Design Project by enhancing general education courses in which pre-service teachers commonly enroll. The performance period for this project is from February 1, 2002 through August 31, 2002.

Physician Assistant Training Grant (PD# 020807)

Malcolm X College has been awarded \$212,761 for the first year of a three year grant which will support the PA program at Malcolm X. The project will support recruitment efforts, retention strategies, faculty development activities and the upgrade of technology systems for enhancing the curriculum and improving the administration of the physician assistant program at Malcolm X. The first year of funding begins July 1, 2002 and ends June 30, 2003.

Gallery 37 (PD# 020808)

The Washburne Culinary Institute has received funding of \$16,000 from the Chicago Department of Cultural Affairs for a project to offer a program of culinary arts curricular experiences. The performance period for the project is from August 1, 2002 to June 30, 2003.

Malcolm X Talent Search (PD# 020809)

Malcolm X College has received funding from the U.S. Department of Education for a project that will provide educational services to encourage youth (11 to 27 years old) to complete secondary school and seek and enroll

in post-secondary education. The project has been awarded \$190,000 for the first year of a five year project. The performance period for this project is from September 1, 2002 through August 31, 2007.

Malcolm X Educational Opportunity Center (PD# 020810)

Malcolm X College has received funding from the U.S. Department of Education for a project that will provide educational services to enable adults of 19 years old or older to become potential students for post secondary programs. The project has been awarded \$200,000 for the first year of a five year project. The performance period for this project is from September 1, 2002 through August 31, 2007.

Armed Security Guard Training Program (PD# 020811)

Olive-Harvey College has submitted a proposal to the Mayor's Office of Workforce Development (MOWD) for \$80,000. The project would help residents of the Olive-Harvey community to obtain and maintain employment in the security industry. The performance period for this project is from October 1, 2002 through September 30, 2003

Cook County Physician Assistant Scholarship (PD# 020812)

Cook County has awarded \$100,000 to be used as financial assistance for students in the Malcolm X Physician Assistant Program. The performance period for this project is from January 1, 2003 through December 31, 2004.

Technology-Enhanced Adult Education in Chicago: A Community Technology Center (PD# 020815)

Daley College has submitted a request for \$294,824 to the U.S. Department of Education for funding to create a center which would provide access to current computer technology for residents of the southwest side of Chicago. The performance period for this project is from October 1, 2002 through September 15, 2003.

SBC Excelerator Project (PD# 020817)

Daley College, in partnership with John Hancock High School, has submitted a proposal for \$53,312 to the SBC Ameritech Foundation for a project to bridge the digital gap and build student technology skills by working in an intergenerational technology access program. The performance period for the project is from August 1, 2002 through July 31, 2003.

SBC Excelerator Project (PD# 020818)

Daley College, in partnership with the West Side Technical Institute, has submitted a proposal for \$460,139 to the SBC Ameritech Foundation for a project to upgrade computer software and hardware at Daley and West Side Technical Institute. The performance period for the project is from August 1,

2002 through July 31, 2003.

CONTINUATION GRANTS

Illinois Cooperative Work Study Program (PD# 020801)

Kennedy-King College has been funded by the Illinois Board of Higher Education for a Cooperative Work Study Program grant for \$11,200. The project would offer students an opportunity to gain work experience for which they would earn both salary and college credit. The College has formed partnerships with community businesses and organizations to provide the internships. The performance period for the project is from April 2, 2002 through June 30, 2003.

Foster Parent Training (PD# 020803)

Harold Washington College has received a contract from the Illinois Department of Children and Family Services for \$947,060 to provide foster parent training activities for the period from July 1, 2002 until June 30, 2003.

State Prekindergarten Sub-contracting Project (PD#020804)

The District Office has been awarded \$549,762 by the Chicago Public Schools to continue to provide preschool experience for 210 three and four year old children who are at risk of academic failure at Daley, Kennedy-King, Malcolm X, Oliver-Harvey and Truman Colleges and at Dawson Technical Institute Child Development Centers. The performance period for the project is from July 1, 2002 to June 30, 2003.

IDHS Site Administered Child Care Program (PD# 020805)

The District Office has received a contract from the Illinois Department of Human Services for \$565,400 to subsidize child care payments for low-income families. The performance period for this project is from July 1, 2002 through June 30, 2003.

Child Care Access Means Parents in School (PD# 020806)

The District Office has been funded for the second year by the U.S. Department of Education for a project which expands day care services to children of students who are needy but not currently eligible or who do not have access to day care facilities. The second year of funding is for \$235,207 and will be used to expand day care services at five of the colleges: Daley, Kennedy-King, Malcolm-X, Olive-Harvey, and Truman. The period of performance for the four year project is from June 15, 2001 until June 14, 2005.

Cooperative Work Study at Washington College (PD# 020813)

Harold Washington College has received a grant from the Illinois Board of

Higher Education for \$27,000 which will support the Washington College cooperative work study program by paying a portion of the salaries that students earn while in their internship positions in business and industry. The performance period for the projects is from April 2, 2002 until June 30, 2003.

Cooperative Work Study at Wright College (PD# 020814)

Wilbur Wright College has received a grant from the Illinois Board of Higher Education for \$35,000 which will support the Wright College cooperative work study program by paying a portion of the salaries that students earn while in their internship positions in business and industry. The performance period for the projects is from April 2, 2002 until June 30, 2003.

Educational Talent Search (PD# 020816)

Kennedy-King College has received continuation funding from the U.S. Department of Education for the second year of funding for its Talent Search grant funded project at Dawson Technical Institute. The second year funding is for \$285,615 with the five-year total being \$1,547,177. The project provides support services to students to enable them to attend college. The performance period for this project year is from September 1, 2002 through August 31, 2003.
