- > Career Advantage as Counseling 101/111 for a flat fee of \$2,800 (September 1, 2000 through Summer 2003);

that the Board of Trustees approve this Agreement with PBS stating the terms and conditions whereby the City Colleges of Chicago may be granted telecourse licenses for use in learning centers for \$12,250.00 plus an enrollment fee of \$20.00 per student; and authorize the Chairman to execute said Agreement on behalf of the Board.

RECOMMENDS:


