APPROVE EMERGENCY EXCEPTION TO PART-TIME LECTURER COURSE/CONTACT HOUR MAXIMUM AT WILBUR WRIGHT COLLEGE

- WHEREAS, Board policy, as set forth in Board Report #22337 (adopted December 2000) limits part-time credit lecturer assignment to a maximum of three (3) courses or a ten (10) pay hours per week;
- WHEREAS, due to an emergency medical leave by a full-time physics/physical faculty member at Wright College, three classes in the physical sciences are without instructors for the Fall Semester 2002;
- WHEREAS, in accordance with the provisions of the Cook County College Teachers Union, Local 1600, AFT collective bargaining agreement, the administration at Wilbur Wright College has offered extra work to other full-time faculty in the District to staff the two classes but no full-time faculty members have applied for the extra work;
- WHEREAS, three part-time credit lecturers, Kathleen Nebril, Natalie Zavelsky, and William Kennedy have applied to teach the courses but assignment of the courses to them will result in an course/contact hour load assignment of eleven (11), twelve (12), and twelve (12) contact hours respectively, (for the Fall Semester, an amount in excess of maximum weekly pay hour load allowed by the Board Resolution #22337;
- WHEREAS, due to the above-mentioned exigent circumstances, it is the best interest of the District to make an exception to the Board policy with respect to course/contact load limit established by Board Resolution #22337 in connection with the assignment of classes to Kathleen Nebril, Natalie Zavelsky and William Kennedy for the Fall Semester 2002;

NOW, THEREFORE, the Board hereby resolves that:

the Chancellor is authorized to approve the assignment of contact hour load to part-time credit lecturers in excess of the maximum established in Board Report #22337, for the Fall Semester 2002 as follows: Kathleen Nebril – eleven (11) contact hours; Natalie Zavelsky – twelve (12) contact hours; and William Kennedy – twelve (12) contact hours.

- WHEREAS, in accordance with the provisions of the Cook County College Teachers Union, Local 1600, AFT collective bargaining agreement, the administration at Wilbur Wright College has offered extra work to other full-time faculty in the District to staff the two classes but no full-time faculty members have applied for the extra work;
- WHEREAS, one part-time credit lecturer, Julie Bruska, has applied to teach the courses but assignment of the courses to her will result in a course/contact hour load assignment of twelve (12) contact hours for the Fall Semester, an amount in excess of maximum weekly pay hour load allowed by Board Resolution #22337;
- WHEREAS, due to the above-mentioned exigent circumstances, it is in the best interest of the District to make an exception to the Board policy with respect to course/contact load limit established by Board Resolution #22337 in connection with the assignment of classes to Julie Bruska for the Fall Semester 2002;
