CITY COLLEGES OF CHICAGO END-OF-TERM ENROLLMENT REPORT: SPRING 2002

THE CHANCELLOR

REPORTS that unduplicated headcount end-of-term enrollment in all programs reached 86,049 students, and the Full-Time-Equivalent (FTE) enrollment reached 41,678 FTE students (Tables 1 and 2).

Headcount enrollment in the credit program reached 30,562 students, an increase of 6.8 percent over the previous year. The credit FTE enrollment reached 17,719 FTE students, which represents an 8.0 percent increase over the previous year.

Headcount enrollment in college credit, pre-credit, and vocational skills reached 34,434 students, an increase of 4.5 percent compared to spring 2001. These programs represent the traditional baccalaureate/transfer, occupational and remedial courses in the district. FTE enrollment reached 19,751 students, an increase of 5.5 percent (Table 2).

Headcount enrollment in the Adult Education program reached 32,020 students, an increase of 1.5 percent compared to spring 2001 (Tables 1 and 3). FTE enrollment reached 17,917 FTE students, an increase of 0.9 percent (Tables 2 and 3).
