The Corporation for Public Broadcasting (CPB), relying on representations made by the applicant in the Application for a Television Community Service Grant and Interconnection Grant, and the certifications and relevant data and information contained in all of the related documents and forms and in the CPB Annual Financial Report for Fiscal Year 2001 submitted by applicant, hereby offers applicant a Fiscal Year 2003 Television Community Service Grant in the amount below.
