LIBRARY MOVING SERVICES HAROLD WASHINGTON COLLEGE RENOVATION PROJECT

REPORTS

May 8,

that as part of Phase I of the renovation project at Washington College, staff prepared and issued a Request for Proposals (RFP) for moving services for the college library; the scope of work includes the relocation of the entire library collection, including 60,000 volumes of books, as well as audio visual and microfilm equipment and other furniture from the current fifth floor library area to storage for approximately 7-8 months during the renovation and then the return of all books, materials, equipment and furniture to the renovated fifth floor location at the college after construction and reshelving of the books in proper library classification order; and

that proposals were received from the following four firms: Hallett Movers, Summit, IL, Midway Movers, Chicago, IL, Midwest Movers, Elk Grove, IL, and Big "O" Movers, Chicago, IL; the proposals were evaluated according to the criteria in the RFP: general experience, specific library moving experience and qualifications, references, compliance with the specifications, as well as pricing; Hallett Movers has by far the most experience with library moves, including approximately 400 library references; in addition, the proposed estimated price of \$57,085 is substantially lower, primarily due to the costs of equipment rental (cartons, pallets, carts), packing, moving and reshelving costs, as well as storage costs for the estimated 7-8 month period; and

that based on staff's review of the proposals, and Hallett Movers' experience and pricing, the proposal from Hallett Movers is recommended for a total estimated cost of \$57,085; and

that this proposal has met the District's MANBE requirement, and has requested a waiver of the WBE requirement pending certification.
