The Board Committee on Academic and Student Services met on Tuesday, November 4, 2003 to hear staff reports.

**Staff Reports:**

**WYCC:** WYCC has developed a direct microwave link from the Northwestern campus to their transmitter site at the Hancock Center, moving the News broadcast time to 6:30 p.m. on Fridays. Opportunities for additional program collaboration and fundraising with Northwestern are being discussed.

A new district-wide team is focusing on marketing opportunities within the high school football and basketball championships to be broadcast on WYCC.

Preparation for our Great Books Town Hall Meeting to be produced at Malcolm X College on Tuesday December 4<sup>th</sup> is underway. The full district collaboration for next semester's Racism project has begun.

Kennedy King alum, Dempsey Travis is the subject of this months' salute with Lorenzo Padron, a graduate of Harold Washington, the subject for December.

**Competitive Grants:** Associate Vice Chancellor Bill McMillan delivered the Fiscal Year 2003 Cumulative Report of Grants, Contracts and Gifts and presented the Prospectus on the Competitive Grants Initiative prepared by the Academic Affairs Office of Grants and Contracts. The Report's Summary noted that of 127 competitive grant submissions, 89 were funded, for a funding rate of 70%. The Prospectus detailed activities to increase the number of successful grant and contract proposal submissions. The Chancellor and the Board recommended that the Office of Grants and Contracts re-evaluate the Prospectus and submit a revision to the Board at the next meeting with one or more alternate recommendations.

**Other:** Daley College President Sylvia Ramos reported CCC and the International Brotherhood of Electrical Workers (IBEW) have entered into an exclusive partnership that allows electrician apprentices to earn an Associate in Applied Science (A.A.S.) degree from Daley College while completing their technical training. The program is also available to current IBEW Local Union 134 members. Building on this partnership program, Daley College, the union and other partners are currently involved in a global effort to create a standardized vocational training program for the electrical construction industry.

END-OF-TERM ENROLLMENT REPORT: SUMMER 2003

THE CHANCELLOR

REPORTS that as of the end of summer 2003, unduplicated headcount enrollment in all programs reached 51,168 students, and the Full-Time-Equivalent (FTE) enrollment reached 23,226 FTE students (Tables 1 and 2).

Headcount enrollment in the credit program reached 13,667 students, an increase of 4.7 percent over the previous year. The credit FTE enrollment reached 8,801 FTE students, which represents a 3.7 percent increase over the previous year.

Headcount enrollment in college credit, pre-credit, and vocational skills reached 15,201 students, an increase of 3.1 percent compared to summer 2002 (Table 1). These programs represent the traditional baccalaureate/transfer, occupational and remedial courses in the district. FTE enrollment reached 9,600 students, an increase of 2.0 percent (Table 2).

Headcount enrollment in the Adult Education program reached 24,983 students, a decrease of 1.2 percent compared to summer 2002 (Tables 1 and 3). FTE enrollment reached 12,284 FTE students, a decrease of 2.5 percent (Tables 2 and 3).

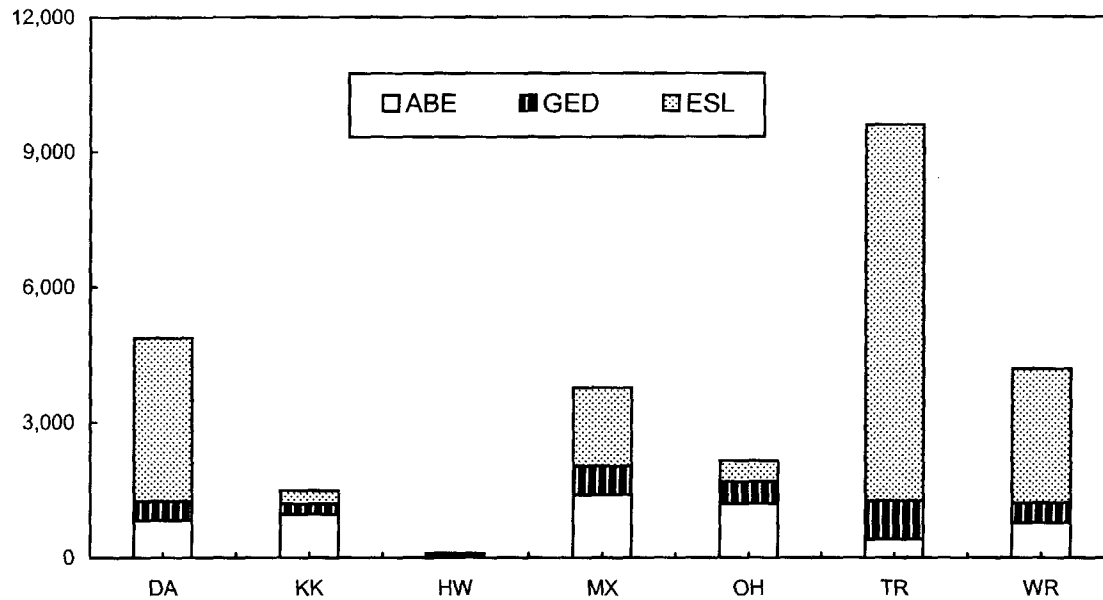
