RENEWAL OF COMMERCIAL INSURANCE POLICIES
FOR PROPERTY, BOILER AND MACHINERY, AND COMMERCIAL AUTO

THE CHANCELLOR

REPORTS

That the District requires commercial insurance coverage to insure certain risks facing the District in its operations; and

that Arthur J. Gallagher & Co. (Gallagher) was selected by a Request for Proposal process dated July 20, 2001 and approved by the Board of Trustees as the Broker of Record for City Colleges of Chicago (CCC). Lambent Risk Management Services, Inc. serves as the MBE Vendor Partner and in conjunction with Gallagher actively marketed and secured the following renewal premium quotations on behalf of CCC for commercial insurance policies for the period November 3, 2004 through November 3, 2005 (Property, Boller & Machinery, Auto expire January 1, 2005); and

that on November 4, 2004 the Board of Trustees authorized procurement of various commercial insurance policies under Board Report Number 26438 as recited below:

that following the action of the Board of Trustees upon binding coverage, the Broker received a revised quotation from Affiliated FM Global concerning the proposed annual premium for the Property Policy (Real Estate and Contents), the Boiler & Machinery Policy and the Commercial Auto Policy in the amount of \$500,000; and

that the amended premium quotation from Affiliated FM Global is \$109,485 less than the Travelers Insurance quotation; and

that Affiliated FM Global reflects an AM Best Rating Guide of "A+", XV; and

that the Affiliated FM Global proposal meets all of the District specifications concerning coverage limits, financial strength and capacity and is recognized as a industry leader with respect to Property Insurance; and

that the comparison reflects the Travelers proposal and the Affiliated FM Global proposal to be substantially the same with the exception of minor coverage differences which the District considers to be a prudent risk on its part: and

that the revised net decrease over the current year combined adjusted premium of \$1,303,858 to the proposed premium of \$1,036,014 represents a net reduction of \$267,844 or 20.54%.

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees approves the procurement of renewal insurance for the Property Policy (Real Estate and Contents), the Boiler & Machinery Policy and the Commercial Auto Policy in the amount of \$500,000 for a period of one year underwritten by Affiliated FM Global at the recited limits and deductible/retention levels expressed below, brokered through Arthur J. Gallagher & Co and Lambent Risk Management Services, Inc.; and
