BE IT FURTHER RESOLVED, that the signatories listed on Section I of Appendix 29 are hereby authorized to (1) enter into agreements with the designated depositories for treasury/cash management services (2) take any and all actions, upon such terms and conditions of the foregoing agreements and/or services as to them shall seem proper (3) open or close any and all accounts (4) delegate to others the authority to take any and all actions, upon such terms and conditions of the foregoing agreements and/or services as to them shall seem proper; and

BE IT FURTHER RESOLVED, that the signatories listed on Section I of Appendix 29 are hereby authorized to, upon such terms and conditions of the foregoing agreements and/or services as to them shall seem proper: (1) to deliver and deposit with such depository for safekeeping or other purposes any bonds or other property owned or otherwise held; (2) to withdraw, receive, and receipt for, and to withdraw upon trust receipt; and to sign orders and issue instructions for the handling, transfer, registration, sale substitution, exchange, and delivery of any bonds and other property and the proceeds thereof, delivered to, deposited with, or otherwise held by such depository for the account; such withdrawals, whether subject to payment or not and whether pursuant to sale, exchange, or other transaction, may also be made by the bearer or any order,

receipt, or request so signed, and (3) to purchase bonds, certificates of deposit, treasury bills, other obligations of the federal government and other property, and to sign orders and issue instruction in connection with deposit of funds in Time Deposit- open accounts or with the purchase, payment registration, and delivery thereof, and (4) to sell, transfer, assign, exchange, or otherwise dispose of bonds, certificates of deposit, and other property, and to sign orders and issue instructions regarding the handling of any matters connected with such transactions; and

BE IT FURTHER RESOLVED, that all signatories listed on Appendix 29 are hereby authorized to (1) endorse for deposit any and all checks, drafts, or orders payable to or belonging to the Board and that said endorsement may be made in writing or by stamp without designation of the person so endorsing; (2) sign (manually, via facsimile or otherwise) checks, drafts, or orders for withdrawals of funds to the credit of the Board in any account or accounts in the depository and that the depository is hereby authorized to honor said checks, drafts, or orders without inquiring as to the circumstances of their issue or to the disposition of the proceeds; and

BE IT FURTHER RESOLVED, that such depositories of the Board be and it is hereby requested, authorized, and directed to honor checks, drafts, or other orders for the payment of money drawn in the Board's name, including those drawn to the individual order of any person or persons whose name or names appear thereon as signer or signers thereof, when bearing or purporting to bear the facsimile signatures of any persons authorized to so sign such checks, drafts, or other orders, and the depository shall be entitled to honor and to charge the Board for all such checks, drafts, or other orders, regardless of by whom or by what means the facsimile signature or signatures thereon may have been affixed thereto, if such facsimile signature or signatures resemble the facsimile specimens duly certified to or filed with the depository by the Secretary, Assistant Secretary, or other officer of the Board; and

BE IT FURTHER RESOLVED, that the Secretary or Assistant Secretary of the Board be authorized to certify to the depository a copy of these resolutions and the name and signatures of the officers authorized to act in the premises and that the depository is hereby authorized to rely upon such resolutions until formally advised by like certification of any changes therein.
