that there is a need to purchase the following Apple Computer hardware, software and maintenance for the graphic arts programs at Kennedy-King College and Wright College, and the digital multimedia program at Washington College:

Wright College - \$31,569.00

- 1 - Power Mac G5 Dual 2 GHz
- 2 - Power Mac G5 1.86 GHz
- 24 - eMac 1.25 GHz
- 24 - APP for eMac – maint.
- 2 - APP for Power Mac – maint.

Washington College - \$18,886.95

- 1 - Apple Server – Xserve G5 2.0GHz, including accessories (rack, UPS system, surge protector)
- 4 - iMac G5 17" 1.6 GHz Combo Drive
- 5 – Production Suite Software
- 18 – Final Cut Pro HD Software

Total Cost – All Colleges - \$65,640.67

and that the proposals from Apple have been reviewed and approved by college staff; this purchase is a sole source with Apple Computer and includes the Apple educational discount; and

that the purchase of Apple computers, software and maintenance services is based on receiving an academic discount directly from the manufacturer, therefore, Apple computer shall indicate good faith efforts to be in compliance with the District's M/WBE Participation Plan.

RECOMMENDS

that the Board of Trustees authorizes the Chairman to enter into the hardware maintenance contract and software license agreements above for a total cost of \$9,731.00 and approves the issuance of a purchase order in the total amount of \$55,909.67 to Apple Computer, Austin TX to purchase the Apple products and services listed above for Kennedy-King, Washington and Wright Colleges.
