that Administrative Services employed the engineering services of WMA Consulting Engineers to aid in the review and bid analysis process along with appointing a CCC review committee; and

that two firms submitted proposals in response to the RFP, namely Johnson Controls, Inc. and Ameresco, Inc., each bringing different ideas and approaches to the project; and

that it was the joint decision of the engineering consultant and the CCC review committee that both companies are qualified to provide the project services and that the project should be divided by means of major components with each firm performing aspects of the project that were considered most favorable to CCC; and

that it was determined that two energy performance contracts be entered into as follows:

that the Office of M/WBE Contract Compliance has reviewed the above referenced mechanical and infrastructure improvement proposals at Malcolm X College and has determined that the recommended performance contracts that include both Johnson Controls, Inc. and Ameresco, Inc. are together in compliance with the Board approved Contract Participation Plan; and

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees authorize the Chairman to enter into performance contracts with Johnson Controls, Inc. and Ameresco, Inc. for the services related to the Energy Upgrade Project at Malcolm X College and West Side Learning Center in an amount not to exceed \$22,455,500.00 between the two contracts.
