#### **REPORTS**

that there is a need to utilize the services of Dr. Donald Barshis, former Executive Dean of Instruction at Wright College and continue his role as a principal consultant for the Wright College's FIPSE-funded Great Books Program Grant, consult in the phase of the College's related NEH Grant to develop Great Books curricula, and perform the following tasks:

- Assist Project Director in Planning and Implementing two National Conferences for National Great Books Consortium Partners -10 days (5 days in November 2005, 5 days in spring 2006)
- Project Evaluation Activities-research, report writing, interviews, meetings- 6 days (throughout grant period)
- Assist Project Director in Planning and Implementing Local Meetings and Projects with Local Partners (Wright College, Harold Washington College, and Oakton College) - 4 days (2 days in fall 2005, 2 days in spring 2006)
- Review Curriculum Materials and Other Submissions to National Great Books Website
  includes reading, editing, corresponding with faculty and project staff- 4 days (throughout
  grant period)
- Assist Project Director in Other Grant Management Activities-preparation for FIPSE reports and director's conferences, liaison work with administration at partner institutions, troubleshooting fiscal issues-4 days (throughout grant period)

that Dr. Barshis possesses the administrative expertise as well as the intimate knowledge of Great Books Programs at both a local and national level to serve as a consultant for both of Wright College's Great Books grants; staff recommends approval to utilize his services during the period of November 3, 2005 through August 31, 2006, \$500/day for 28 days or \$75/hour for 187 hrs. for a total not to exceed the cost \$14,000.00 for the year.

that the Office of M/WBE Contract Compliance has reviewed the above referenced consulting opportunity and since Dr. Barshis provides the on-going consistency knowledge and familiarity with the externally-funded Great Books program at Wright College, it is recommended that a waiver from both MBE and WBE goals be approved.
