that is it necessary to purchase books, periodicals, reference books and instructional materials yearly for libraries, and for students in various programs at all colleges, including Health Occupation Career Programs, Computerized Numerical Control, Tool Technology and Offset Printing and Food Services at Dawson Technical Institute, Kennedy-King College; and

that a Request for Proposal for Textbooks, Periodicals, Reference Books, and Instructional Materials was publicly advertised on January 9, 2006, to choose vendor(s) to serve as both a primary vendor and a preferred vendor; and

that the primary vendor will provide textbooks to support college curriculum courses; and

that the preferred vendors will provide periodicals, educational related audiovisual products, online database software and other instructional media products; and

that textbooks include trade edition books, university press editions, and publisher library editions; and

that educational media products include videocassettes, DVDs, spoken word cassettes, CDs and CD ROMs; and

that five (5) firms responded to the RFP: H.W. Wilson, Steck-Vaughn, Thomson/Gale, Baker & Taylor and EdMap, and the submitted proposals were reviewed, evaluated and ranked by District Office Staff and campus librarians in accordance with evaluation criteria outlined in the RFP; and

that based on the evaluation scoring, staff recommends acceptance of the proposals from the following firms as Primary and Preferred Vendors:

Wilson a preferred vendor for \$90,000, for a three year period beginning June 30, 2006 through June 29, 2009 with an option to extend for an additional two (2) year period, in accordance with RFP# IW0602 dated January 1, 2006.
