AMEND THE AGREEMENT WITH INNOVATIVE INTERFACES INC. LIBRARY AUTOMATION SYSTEM SOFTWARE SUPPORT AND MAINTENANCE SERVICES ALL COLLEGES AND DISTRICT OFFICE (Amend Board Report # 26824) dated July 14, 2005)

THE CHANCELLOR

REPORTS

that in Board Report 26824, dated July 14, 2005, the Board approved a software license and maintenance support agreement for District-wide access to Innovative Interfaces Inc. library automation system which provides a web-based online public catalog and the automation of library tasks; and

that Innovative Interfaces, Inc. has submitted a proposal to provide software maintenance and support for the period of July 1, 2006 through June 30, 2007 for a cost not to exceed \$30,132.00; and

that during the 2006 spring break, when the libraries were closed, OIT required additional technical assistance from Innovative Interfaces, Inc. to migrate the library system to a new server to improve performance at a one-time cost of \$7,500.00; and is requesting payment ratification to cover the services provided; and

that OIT staff has determined that the proposal from Innovative Interfaces Inc. is reasonable and acceptable, and recommends approval of the software support and maintenance service agreement for the period indicated above and this software maintenance service is exempt from the District's competitive bidding requirements; and

that the expenditure for these services is funded through the Office of Information Technology FY07 Operational budget; and

that the Office of MWBE Contract Compliance has reviewed the above referenced amendment and has determined that since Innovative Interfaces is continuing under a previous Board approval it is recommended that a waiver from compliance with the Board approved Participation Plan be granted.

RECOMMENDS

that the Board of Trustees ratify the payment of \$7,500.00 for services performed during the spring 2006 recess to migrate the library system to a new server and; the negotiation and the amendment of an agreement with Innovative Interfaces Inc. for the period July 1, 2006 through June 30, 2007 for software support and maintenance service in a total amount not to exceed \$30,132.00 and authorizes the Chairman of the Board to execute any documents pertaining to these services.

that in Board Report 23608, dated January 7, 2003, the Board approved a software license and maintenance support agreement for district-wide access to Innovative Interfaces Inc. library automation system which provides a web-based online public catalog and the automation of library tasks; and

that Innovative Interfaces, Inc. has submitted a proposal to provide software maintenance and support for the period of August 1, 2005 through June 30, 2006 for a cost not to exceed \$27,621.00; and

that OIT staff has determined that the proposal from Innovative Interfaces Inc. is reasonable and acceptable, and recommends approval of the software support and maintenance service agreement for the period indicated above and this software maintenance services is exempt from the District's competitive bidding requirements; and

that the expenditure for these services is funded through the Office of Information Technology FY06 Operational budget; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced software maintenance support opportunity and has determined that since Innovative Interfaces, Inc. is the developer of the software used by our libraries and is considered a sole source activity, thus making this agreement fall outside of the Board approved Participation Plan.

RECOMMENDS

that the Board of Trustees approve the negotiation of an agreement with Innovative Interfaces Inc. for the period August 1, 2005 through June 30, 2006 for software support and maintenance services in a total amount not to exceed \$27,621.00 and authorizes the Chairman of the Board to execute any documents pertaining to these services.
