that Acxiom has proposed to continue providing the District's annual operational mainframe processing and data storage needs through June 30, 2007 and that OIT has estimated the FY07 cost not to exceed \$966,178.00; and

that OIT has reviewed the proposal and finds it to be reasonable and acceptable; and that this purchase of professional services is exempt from the District's competitive bidding requirements; and

that the expenditure for these services is funded through the Office of Information Technology FY07 Operational budget; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced amendment and has determined that since this transaction is a continuation of a previous Board approved contract it is recommended that a waiver from compliance with the Board approved Participation Plan be granted.
