## BUS TRANSPORTATION SERVICES ALL COLLEGES

### THE CHANCELLOR

#### REPORTS

that there is a continuing need for the colleges to utilize bus services throughout the year for various programs, including but not limited to: The National Youth Sorts Program (NYSP) at Malcolm X., Daley and Truman Colleges each summer, the Taxicab Training Program sponsored by Washington College, the Upward Bound program at Daley, and transportation for sports teams at various colleges throughout the year; estimated District-wide expenses for bus service for FY2006 were approximately \$90,000.00; and

that the vendors listed below have been approved under a Chicago Public Schools (CPS) contract through June 30, 2008 and it is recommended that the Board utilize the CPS contracted vendors through a joint-purchase arrangement to provide bus services for City Colleges; and

that the colleges will be required to obtain quotations from these vendors as needed for their bus transportation requirements; and

that the cost for bus transportation may vary depending on the number of people traveling and destination; and

that based on previous transportation costs the following bus companies may exceed \$10,000 from July 1, 2006 through June 30, 2008.
