**NEW PROPOSALS OR GRANTS**

**Machinist Textbooks (PD# 061101)**

Daley College has received an award of \$3,000 from Illinois Department of Commerce and Economic Opportunity to provide textbooks and materials for students in the new machinists training program which is offered to veterans. The performance period for this award is from March 15, 2006 through March 14, 2007.

**Re-Enrolled Student Project at Olive Harvey (PD# 061103)**

Olive Harvey has received an award of \$80,000 from The Alternative Schools Network, in Chicago for a project that will provide certified academic skills instructors to enhance the use of computer labs for academic programs at the Olive Harvey Middle College to better prepare students for post secondary education. The performance period for this award is from August 30, 2006 through July 31, 2007.

**Illinois Basic Operating Grant (PD#061104)**

WYCC Channel 20 has received notice of the refunding of its grant from the Illinois Arts Council for \$16,650 to be spent on basic operating costs of WYCC. The performance period for this project is from September 1, 2006 through August 31, 2007.

**Illinois Schoolyard Habitat Action Project (PD#061105)**

Truman College has submitted a proposal to the Illinois Department of Natural Resources for a grant of \$600 to relocate and restore a native prairie site damaged by construction at the College. The performance period for this project is from January 1, 2007 through January 1, 2008.

**Community Service Grant (PD# 061107)**

WYCC-TV has received notification of anticipated funding of \$773,788, for

the Television Community Service Grant from the Corporation for Public Broadcasting. This grant supports the basic operation of WYCC-TV and the performance period for the grant project is from October 1, 2006 until September 30, 2008.

**Interconnection Grant (PD# 061108)**

WYCC-TV has received notification of anticipated funding of \$15,969 for the Interconnection Grant from the Corporation for Public Broadcasting. This grant supports the basic operation of WYCC-TV and the performance period for the grant project is from October 1, 2006 until September 30, 2007.

**CONTINUATION GRANTS**

**P-16 Initiative (PD# 061102)**

The P-16 Initiative has been refunded by the Illinois State Board of Higher Education, as part of its fiscal year entitlement awards, for \$213,171.

**Head Start Support Services Program (PD# 061106)**

The City of Chicago, Department of Human Services has awarded Harold Washington College the amount of \$598,331 to provide Head Start Supportive Services, including support for the Teacher Assistant Program, the AA-Early Childhood Program, the AA-Social Services Program, the Child Development Associate Program for Family Child Care Home Providers and the Child Development Associate Program for Center-Based Head Start. The performance period for this funding is from December 1, 2006 through November 30, 2007

**AMENDMENTS**

**Integrated Systems Technology (PD#050203)**

Daley College will receive a subcontract, of \$228,604, from an award to Illinois State University made by the US Department of Labor. The project will develop and pilot a model to utilize integrated systems technology to train incumbent workers in the Chicago area in advanced manufacturing careers. The performance period for the project is from October 1, 2004 through June 30 2006. *Daley has now received a "no-cost" extension which changes the end date of the project to December 15, 2006.*

**Truants' Alternative and Optional Education Program (TAOEP) (PD# 060520)**

The District Office anticipates funding of \$2,000,000 for a continuation

project from the Illinois State Board of Education. This program is a unique partnership between public, private and community-based organizations designed to provide alternative educational programs and services to reclaimed youth, 16-21 years old, who have dropped out of high school. The Truman Middle College will receive \$244,208 and the Olive Harvey Middle College will receive \$267,460 from this funding. The performance period for this project is from July 1, 2006 through June 30, 2007. From the grant funds, the following diploma programs and GED programs will utilize subcontracts from the City Colleges of Chicago:

*The actual funding agreement awards \$60,000 to Sullivan House rather than \$50,000 as previously reported. The Middle Colleges at Olive Harvey and Truman will be receiving \$414,010 each. In addition, the award for Bronzeville High School will be changed to \$35,000 and will be subcontracted to Blue Gargoyle Youth Service Center as the fiscal agent for Bronzeville High School.*

**Exploring New Models for Authentic Undergraduate Research with Two-Year College Students (PD# 060616)**

Harold Washington College has submitted a proposal to the National Science Foundation for \$3,031,802 to support a collaborative project which will link ten 2-year colleges with research institutions in the Chicago area to support productive research experiences for students.

*The City Colleges of Chicago has been notified that it has been awarded a five-year, \$2.7 million grant that will provide support for community college students and chemistry faculty to engage in authentic undergraduate research, and assist in their transition to four-year colleges to complete their research and undergraduate degrees. The revised performance period for this 60 month project, including all subcontract awards, is from October 1, 2006 through September 30, 2011.*

**Cooperative Work Study (PD# 060620)**

Harold Washington College has received an award from the Illinois Board of

Higher Education for \$26,000, to support cooperative work study programs by paying a portion of the salaries that students earn while in their internship positions in business and industry. The performance period for this project is from April 4, 2006 until June 30, 2007. *The following companies will participate in this project and will receive the amounts indicated as a 50% reimbursement of the cost of the internship salaries:*

**Collaboration to Improve Hispanic Transfer & Degree Completion (PD# 041114-Yr3)**

Truman College has received an award of \$696,983 for the third year of a five year project in which Truman and St. Augustine College will collaborate to support transfer systems and improve faculty skills for the success of predominately Hispanic students. The funding is from the U.S. Department of Education under its Title V: Developing Hispanic Institutions Program. The performance period for Year Two is from October 1, 2005 through September 30, 2006 and the period for Year Three is from October 1, 2006 through September 30, 2007. The grant funds St. Augustine College through subcontract agreements through Truman College and for Year Two, the maximum amount St. Augustine can receive in its subcontract is \$258,459 and for Year Three, the maximum subcontract amount is \$263,423.

**Latino Technology Center (PD#060622)**

Wright College has received a subcontract award for \$67,100 from an award to the Battelle Memorial Institute from the US Department of Energy. The funding will allow Wright College's Humboldt Park Vocational Education Center (HPVEC) to develop a curriculum on wireless technology to be utilized for the Latino Development and Technology Commercialization

Center. HPVEC will also recruit, screen and assess students and offer basic math and English components of the training. The performance period for this project is from April 10, 2006 through December 31, 2006. *The award includes funding of \$13,500 for a consultant, Ms. Stephanie Sommers, to present research results to the project's advisory group and complete a program/curriculum plan in accordance with criterion specified in the funded proposal. Ms. Sommers will also conduct research on the topic of wireless curriculum elements and materials.*
