DISTRICT AGREEMENT WITH BLUECROSS BLUESHIELD OF ILLINOIS FOR THE HMO MEDICAL PLAN

THE CHANCELLOR

REPORTS

that Humana Inc. has been the insurance company for the Health Maintenance Organization (HMO) Medical Plan for employees and retirees of the City Colleges of Chicago since 1999, and for the HMO Medical Plan for Medicare-eligible retirees since 2001; and

that the City Colleges of Chicago wishes to terminate its relationship with Humana Inc. as the Insurance Company for the HMO Medical Plans effective January 31, 2007; and

that the Joint Union-Administration Committee comprised of a Chancellor designee and designees from the Local 1600 and Local 1708 Unions as well as the City Agency HMO Coalition recommends BlueCross BlueShield as the new insurance company for the HMO Medical Plan effective February 1, 2007; and

that the proposed BlueCross BlueShield Monthly Rates for HMO medical coverage for employees and retirees are as follows:
