AGREEMENT WITH UIC COLLEGE OF DENTISTRY-CLINICAL FACILITIES DENTAL HYGIENE PROGRAM KENNEDY-KING COLLEGE

(Amend Board Report 26914, dated September 8, 2005 and Board Report # 18770, dated September 7, 1995)

THE CHANCELLOR

REPORTS

that in Board Report# 26914 dated September 8, 2005, the Board approved execution of an agreement with the University of Illinois at Chicago, College of Dentistry, to utilize the clinical and laboratory facilities of the College of Dentistry for students in the Dental Hygiene Program at Kennedy-King College for a ten (10) year period in an amount not to exceed \$215,000 per year, for the continuation of the Dental Hygiene Program; and

that the \$215,000 per year figure is incorrect; and

that this partnership offers the best of both educational settings and is the only dental hygiene program in the City of Chicago, where all dental hygiene classes and clinical experiences are conducted at the University of Illinois, Chicago College of Dentistry, and taught by professors of dental hygiene and dentistry in a professional atmosphere with access to many educational experiences only available in a College of Dentistry setting, where not more than 30 students are admitted; and

that the correct figures are as follows: tuition for enrollment into the program is estimated at \$ 7,200 for residents of the City of Chicago at \$100 per hour for 72 hours, \$16,503.12 for Illinois residents at \$229.21 per hour for 72 hours and \$22,676.40 for non-Illinois residents/international students at \$314.95 per hour for 72 hours; and, that the annual costs associated with the program will not exceed \$250,000 annually; and

based on the completion of curriculum planning and the receipt of ICCB program approvals for the continuation of the Dental Hygiene Program at Kennedy-King College and in accordance with stipulations of the Agreement, the dental science courses will continue to be taught by UIC faculty; and

that the Office of M/WBE Contract Compliance has reviewed the above clinical facilities agreement and has determined that this activity is sole-source and therefore it is recommended that a waiver be granted from compliance from both the MBE and WBE goals of the Board approved Participation Plan.

THE CHANCELLOR

RECOMMENDS

that the Board of Trustees approve the execution of an Agreement with University of Illinois at Chicago, College of Chicago beginning July 1, 2006 through June 30, 2011, renewable by mutual written agreement for an additional five (5) year period (July 1, 2011 through June 30, 2016) where UIC will make its facilities available for students enrolled in the Dental Hygiene Program at Kennedy-King College and continue for this ten(10) year period subject to Board approval in an amount not to exceed \$250,000 per year for the continuation of the Dental Hygiene Program.
