NEW PROPOSALS OR GRANTS

Child Development Studies Initiative (PD# 070701)

The McCormick Tribune Foundation has awarded \$400,000 to the District Office to build on and strengthen the Child Development Studies Initiative, a district-wide effort to enhanced the Child Development degree programs across the colleges. The performance period for this project is from June 1, 2007 through June 30, 2009.

Illinois Support, Training & Employment Program (ISTEP) (PD# 070702)

Olive Harvey College has received an award of \$58,410 from the Illinois Department of Labor for a project that will assist participating displaced homemakers in achieving economic self-sufficiency through education, training and employment. The project will provide advising, training, career assessment, life skills and job related workshops and referrals to a variety of organizations and agencies. The performance period for this project is from July 1, 2007 through June 30, 2008.

Automated External Defibrillator (PD# 070703)

Th Illinois Department of Public Health has made an award of \$492.53 to Olive-Harvey College to pay for half of the cost of an automated external defibrillator. The performance period for this award is from April 1, 2007 through June 30, 2007.

IBHE Illinois Bridge Project (PD# 070704)

Truman College has received a subaward from Illinois State University, from a grant from The Illinois Board of Higher Education for a program which intends to support students as they complete community college programs

and transfer to university programs. The subaward will allow Truman to organize and teach classes in Biology, Chemistry and Biotechnology. The performance period for the \$15,000 subaward is from May 1, 2007 through August 31, 2007.

NIH Central Illinois Bridge Program (PD# 070705)

Truman College has received a subaward from Illinois State University, from a grant from The National Institutes of Health for a program which intends to support students as they complete community college programs and transfer to university programs. The subaward will allow Truman to organize and teach classes in Biology, Chemistry and Biotechnology. The performance period for the \$30,000 subaward is from March 1, 2007 through March 31, 2008.

Grow Your Own Teachers (PD# 070706)

Truman College has received an award of \$2,000 from the Organization of the Northeast from a grant from the Illinois State Board of Education. The award will allow Truman staff to participate in meetings and project activities for the Grow Your Own Teachers Initiative. The performance period for this award is from May 7, 2007 through August 31, 2007.

High School to Work Transition Program (PD#070707)

Truman College has received a subaward from Jakpan Enterprises from a DCEO award of \$50,000. The subaward to Truman, of \$15,000, will be utilized to encourage college participation for minority high school students by providing college level courses, workforce preparation training and linked internships. The performance period for this project is from July 1, 2006 through October 31, 2006.

Faculty Resource Center (PD# 070708)

Malcolm X College has received an award of \$75,000 for costs associated with the construction of a new faculty resource center. Work will include installation of new ceiling tiles and lighting system, floor carpeting and repairing walls and trim. The performance period for this project is from April 1, 2007 through September 30, 2008.
