**AMEND THE AGREEMENT WITH**  
**COMPUWARE CORPORATION**  
**SOFTWARE LICENSES AND PROFESSIONAL SERVICES**  
**OFFICE OF INFORMATION TECHNOLOGY**  
**DISTRICT OFFICE**  
**(Amend Board Report 27413, dated June 8, 2006)**

**REPORTS**           **THE CHANCELLOR**  
that in Board Report 27413, dated June 8, 2006, the Board approved a license agreement with Compuware Corporation which allows OIT to perform critical performance testing activities such as load testing, performance tuning, application diagnostics and capacity planning of the PeopleSoft Student Administration, Financial and Human Resources systems; and

that OIT has recommended the purchase of additional TestPartner software licenses from Compuware Corporation which will allow monitoring of response time at all colleges at the same time, and requests the continuation of software maintenance services and training services; and

that OIT staff has received a proposal from Compuware to provide the additional TestPartner software licenses at a cost not to exceed \$18,300.00; software maintenance at a cost not to exceed \$48,638.00 for the period of July 1, 2007 through June 30, 2008 and to provide professional services (training services) at a cost not to exceed \$72,000.00 resulting in a total cost not to exceed \$138,938.00; and

that this professional service agreement and purchase of computer software is exempt from competitive procurement; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced agreement amendment and since Compuware would be continuing under their previous waiver from compliance, it is recommended that such a continuation of their waiver from compliance from the Board approved Participation Plan be granted.

**RECOMMENDS**       **THE CHANCELLOR**  
that the Board of Trustees approve the agreements with Compuware Corporation for the TestPartner software license at a cost not to exceed \$18,300.00, software maintenance support for a period of one year from July 1, 2007 to June 30, 2008 at a cost not to exceed \$48,638.00 and a professional services agreement for training services at a cost not to exceed \$72,000.00 resulting in a total cost not to exceed \$138,938.00 including expenses and authorizes the Chairman of the Board to execute any documents pertaining to the software licenses, software maintenance and professional services on behalf of the Board.
