that proposals, contracts, and other special funding instruments are under development or have been submitted by staff at this time.

NEW PROPOSALS OR GRANTS

Malcolm X Educational Opportunity Center (PD# 071101)

Malcolm X College has received funding from the U.S. Department of Education for the first year of a four year project that will provide educational services to enable adults, 19 years old or older, to become potential students for post secondary programs. The project has been awarded \$226,600 for the first funded period. The performance period for this project year is from September 1, 2007 through August 31, 2008.

Susan Harwood Training Grant Program (PD# 071105)

Truman College has been funded by the US Department of Labor's Occupational Safety and Health Administration for \$166,860 to fund a project that will provide targeted topics training related to general industry hazards of powered industrial vehicles. The performance period for this project is from September 30, 2007 through September 30, 2008.

CONTINUATION AWARDS

Building and Energy Technology (PD# 070207-YR2)

Wright College has received a continuation award of \$75,000 from the Illinois Department of Commerce and Economic Opportunity. The project will focus on curriculum-building related to renewable energy and energy efficiency technologies in the construction, assessment, contracting and other associated building sectors. The performance period for this second year of the project is from October 1, 2007 through September 30, 2008.

Center for Authentic Science Practice in Education - CASPiE (PD# 070106 - YR2)

Olive-Harvey College has received an additional \$8,000 from Purdue

University as a subcontract from a National Science Foundation award. The purpose of the funding is to develop and implement a research module for undergraduate physics courses. The total funding received is now \$12,000 and the performance period for this additional funding is from July 31, 2007 through July 31, 2008.

Center for Authentic Science Practice in Education - CASPiE (PD# 070107 - YR2)

Harold Washington College has received an additional award of \$8,000 (for a cumulative total of \$20,000) from Purdue University as a subcontract from a National Science Foundation award. The purpose of the funding is to develop and implement a research module for undergraduate chemistry courses. The performance period for this additional funding is from August 1, 2007 through July 30, 2008.

Head Start / Child Care Collaboration (PD# 071108)

The District Office has received funding of \$768,048 from the Chicago Department of Human Services to provide Head Start and Child Care Day and Nighttime collaborative services for children of low income parents at the Dawson, Kennedy-King, Malcolm X and Olive-Harvey Child Development Centers. The performance period for the project is from December 1, 2007 to November 30, 2008.

Equipment Quality Improvement Grants Program (PD# 071112)

Kennedy-King College has received an award of \$4,000 from the EQUIP program, which is funded by foundations including Pritzker, Guthman, Prince and McCall. The project will develop and implement a new model to improve parent communications at the Child Development Laboratory Center at Kennedy-King College. The performance period for this project is from September 1, 2007 through August 31, 2008.

Collaborative Research: Participation in the MICE Experiment (PD# 071113)

Daley College has submitted a proposal for \$77,559 to the National Science Foundation as part of a larger grant proposal being submitted by Illinois Institute of Technology. The project would demonstrate the feasibility of accelerating muon subatomic particles via the "Muon Ionization Cooling Experiment". Daley's participation would involve students and faculty members in the research during the summer period. The performance period for this project is from August 1, 2008 through July 31, 2011.

AMENDMENTS

Fiscal Year 2008 Total Grants to Districts

The Illinois Community College Board has announced its FY '08 annual awards to Districts based on the Governor's Action (HB 3866 on 8/23/07). The City Colleges of Chicago will receive \$55,892,006 which includes:

- **Workforce Development Grant (PD # 071003)** **\$239,584**
- **P-16 Initiative (PD# 071004)** **\$217,381**
- **Retirees Health Insurance Grant (PD# 071107)** **\$626,600**

The remainder of this award is comprised of the Credit Hour Grant (\$39,410,630), Square Footage Grant (\$397,811) and the Additional Grant (\$15,000,000).

Truants' Alternative and Optional Education Program (TAOEP) (PD# 070620)

The District Office received funding of \$2,100,000 for a continuation project from the Illinois State Board of Education. This program is a unique partnership between public, private and community-based organizations designed to provide alternative educational programs and services to reclaimed youth, 16-21 years old, who have dropped out of high school. The Truman Middle College will receive \$416,010 and the Olive Harvey Middle College will receive \$429,000 from this funding. The performance period for this project is from July 1, 2007 to June 30, 2008. From the grant funds, the following diploma programs and GED programs will utilize subcontracts from the City Colleges of Chicago:

GIFTS OR DONATIONS

Moo & Oink (PD# 071102)

Olive-Harvey College has been notified that they will receive a donation of perishable goods valued at \$100 from Moo & Oink. The donation will be used by Olive-Harvey's College Student Government Association for one of their student activities events.

Schneider National (PD# 071103)

Olive-Harvey College has been notified that the College will received a donation of a 2003 Freightliner 10 speed sleeper truck model C12064ST and a 1979 stainless steel tank trailer model # MC307. The trailer is 42 feet long, 96 inches wide with a 7000 gallon capacity. The total estimated value of the donation is \$41,900.

Auto Zone (PD# 071104)

Olive-Harvey College has been notified that the College will receive a donation of auto spare parts and accessories with an estimated dollar value of \$3,000. Auto Zone is closing one of their locations and wishes to contribute to the Olive-Harvey College's transportation program.

Markzware (PD# 071106)

Kennedy-King College has received a donation of a site license for 20 stations for FlightCheck Pro software for the Macintosh from Markzware, Inc. Markzware estimates the value of the donation at \$9,980.00.

NIKE USA (PD# 071109)

Nike USA, Inc. has agreed to supply footwear, apparel and select equipment to the men's varsity basketball team at Kennedy-King College for three seasons, starting with the 2007-2008 season. The estimated value of the items to be supplied by Nike USA, Inc., is \$45,000 per year for the first and third year(when new warm-up suits and uniforms are supplied) and \$29,200 for the second year.

ComEd Truck (PD# 071110)

ComEd, an Exelon Company, is donating a 1994 International Truck, Altec Model D-842 Digger Derrick with auger 3000 pound lifting capacity and 360 degree rotation to Kennedy-King College for use in the Overhead Electrical Lineworker Program at Dawson Technical Institute. Over \$10,000 worth of improvements have been made on the vehicle, primarily due to the generosity of the Quality Truck and Trailer Corporation. All required inspections have been performed by the Altec Corporation to assure that the

truck is safe and ready for use when transferred to Kennedy-King College. The estimated value of the truck, with improvements, is \$17,000.

Park National Bank (PD# 071111)

Park National Bank has announced that they will make a contribution of Twenty-Five Thousand Dollars (\$25,000.00) to Kennedy-King College for use in supporting marketing efforts of the College and the promulgation of the College's mission. Included in this funding will be a Park National Bank scholarship of \$1,000 for the period of August 1, 2007 to July 31, 2008.
