that specifications were prepared by District Procurement staff, publicly advertised on October 12, 2007 in the Chicago Sun Times, and specifications were sent to (7) seven firms and a pre- proposal conference was conducted on October 18, 2007 and bids were received from (5) five firms, Convoy Marketing LLC, Stone Mountain, GA, Visual Image Systems, Louisville, KY, Axiom Graphics, Livonic, MI, Creative Graphic Solutions Inc., Portage, IN and Banner & Signs Express, Carrollton, TX and the following bids were received;
