REPORTS

that there is a need to purchase various manufacturing equipment for students to use in the Economic Development Training Program at Daley College as identified in the Center for Labor and Community Research Report; and

that specifications were prepared by District Procurement staff, publicly advertised, and mailed to eighteen (18) prospective firms; one firm submitted a no-bid notice and two (2) firms submitted bids; Advanced Learning Systems and J.W Donchin, and split awards were awarded to the two (2) firms for the following items:

and, that staff reviewed the bids submitted by the lowest responsive and responsible bidders, Advanced Learning Systems and J.W Donchin. and have determined that the bids are reasonable and acceptable, and recommend the purchase of manufacturing equipment from Advanced Learning Systems and J.W Donchin; and

that the Office of M/WBE Contract Compliance has reviewed the above referenced purchase of manufacturing equipment and has determined that both Advanced Learning Systems and J.W. Donchin will be using F.W. Cwynar Trucking (WBE) as partial compliance with the Board approved Participation Plan. It is recommended that the goal of MBE compliance be waived.

THE CHANCELLOR

RECOMMENDS that the Board of Trustees approves the issuance of a purchase order to Advanced Learning Systems in an amount-not-to exceed \$22,660.00, and a purchase order to J.W Donchin in an amount-not-to exceed \$ 39, 200.00, for the purchase of various manufacturing equipment for Daley College, in accordance with the Sealed Bid# SC0726 dated August 20, 2007.
